## FISCAL NOTE ANALYSIS

### Analysis

Senate Bill 152 seeks to name the Airport at Ruby, Alaska the Harold Esmailka Airport to honor the influential and inspirational leader in aviation.

Potential signage is anticipated through community efforts and can be supported by aviation staff. Department of Transportation and Public Facilities (DOT&PF) airport program staff anticipate de minimus coordination efforts with the Federal Aviation Administration (FAA) in administrative notifications, modifications of maps and updating of some data systems. Because these efforts are covered under existing program coordination, DOT&PF submits a zero fiscal note.
