Analysis

This legislation makes changes to the appropriation limit for the State of Alaska, as well as requires the Governor to submit a report to the legislature with the calculation of the appropriation limit. This legislation is contingent on enactment into law of an amendment to article IX, section 16, Constitution of the State of Alaska.

The work necessary to implement this legislation can be absorbed with existing resources. Therefore a zero fiscal note is submitted.
