| This bill changes funding for department-approved district-wide early education programs (EEP) operated by a schodistrict by increasing the funding from 0.5 full-time equivalent (FTE) to 1.0 FTE, so each EEP student will be counted average daily membership (ADM) in the public education funding formula.  |                   |

| FY2025 funding under the 0.5 ADM EEP provision is \$2,050.8 (thousands) at a \$5,960 base student allocation. The finote assumes this additional cost as a baseline and adds a \$300.0 (thousands) annual increase to accommodate addistrict participation and program growth.
