## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2025 LEGISLATIVE SESSION**Analysis**

This bill creates a new class of petitioners for protective orders by enabling employers to seek protective orders against individuals for committing or threatening to commit acts of violence against the employer or an employee. Additionally, this bill creates a new misdemeanor crime of violating a workplace domestic violence protective order.

Generally, new crimes result in additional workload for the Office of Public Advocacy - and the Agency does have concerns about the bill's potential impact. However, the Agency is unable to predict the number of petitions that would be filed under this law and, of those, the number that would result in charges related to the violation of those protective orders. The Agency submits a zero fiscal note at this time but will request additional funding in future budget cycles if the legislation results in significant workload increases.
