

Surety bond requirements in all 50 states and Washington, D.C.	
State	Surety bond amount required
Alabama	\$10,000 for used car dealers, rebuilders, or reconditioners; \$25,000 for new car dealer licenses.
Alaska	\$50,000 for passenger vehicles, \$25,000 for motorcycles.
Arizona	\$100,000 for new/used/public consignment motor vehicle dealers. \$25,000 for brokers, wholesale auto auction dealers, wholesale motor vehicle dealers. \$20,000 for automotive recyclers.
Arkansas	\$25,000
California	\$50,000 for vehicle dealers, \$10,000 for motorcycle dealers.
Colorado	\$50,000 for most applicants, \$5,000 for small trailer dealers.
Connecticut	\$50,000 for new or used car dealers, \$5,000 for general or limited repairers.

Georgia	\$35,000
Hawaii	\$200,000 bond for new vehicle dealers selling 10 or more new motor vehicle units a month on an annual basis. \$50,000 bond for new vehicle dealers selling less than 10 new motor vehicle units per month on an annual basis. \$100,000 bond for used motor vehicle dealers selling 60 or more motor vehicle units per month on an annual basis. \$25,000 bond for used motor vehicle dealers selling less than 60 units a month on an annual basis. \$10,000 bond for motorcycle and motor scooter dealers.
Idaho	\$20,000 all retail dealers / \$40,000 wholesale-only dealers / \$10,000 for other vehicles (ATVs, motorcycles, etc.)
Illinois	\$20,000

Iowa	\$50,000
Kansas	\$30,000
Kentucky	Set by state regulation - can range between \$15,000 - \$100,000.
Louisiana	\$20,000 (if you sell <119 units in a year) / \$35,000 (if you sell 120> in a year)
Maine	\$5,000 <50 sales / \$10,000 51-100 sales / \$15,000 101-150 sales / \$20,000 151-200 sales / \$25,000 201> sales
Maryland	Used car dealers \$15,000 - \$150,000 / New car dealers \$50,000 - \$300,000.

North Carolina	\$50,000 for one established salesroom; \$25,000 for each additional salesroom
North Dakota	New or Used Motor Vehicle Dealer: \$25,000 Motor-Powered Recreational (MPR) Vehicle Dealer: \$10,000 Trailer Dealer: \$10,000 Mobile Home and Manufactured Home Dealer: \$50,000 Low-Speed Vehicles Dealer: no bond required
