FISCAL NOTE ANALYSIS

STATE OF ALASKA 2025 LEGISLATIVE SESSION

Analysis

The bill requires the Department of Health (Department) to implement continuous Medicaid eligibility for children aged 0–6 through a Medicaid Section 1115 demonstration waiver. The Department would contract with a consultant to support development, submission, federal negotiations, implementation, and monitoring for the required waiver. Additionally, the Department would establish a new position within the Office of Health Savings in the Commissioner's office to manage the contractor, oversee waiver activities, facilitate stakeholder engagement, coordinate reporting, and provide ongoing support. In accordance with federal Section 1115 demonstration waiver reporting requirements, the contractor would prepare an interim report in FY2030 using data from FY2027–FY2029.

All listed expenditures are eligible for 50 percent federal reimbursement.

Associated Costs Include:

Personal Services: \$123.2 annually, starting in FY2026, for one non-permanent exempt Project Coordinator (range 20), step C, based in Anchorage, including salary and benefits.

Services: \$20.0 annually, starting in FY2026, for office space and reimbursable service agreements supporting the position. Additional contractual costs for consultant services include:

FY2026: \$250.0 for stakeholder engagement, public notice, waiver application preparation, submission, and federal negotiations support.

FY2027-FY2029: \$100.0 annually for ongoing monitoring, reporting, and technical assistance.

FY2030: \$200.0 for interim evaluation, renewal preparation, and stakeholder outreach.

FY2031: \$250.0 for comprehensive renewal activities, federal negotiation, and technical support.

Commodities: \$5.0 in FY2026 for initial setup (furnishings, computer equipment, monitors, cell phone). Ongoing annual commodity costs are estimated at \$2.0 thereafter for office supplies.
