Dear House Health and Social Services Committee Members:

Please do not pass SB 89. Regardless of your position on abortion, the bottom line is money. By passing this bill you will send a message to the school district that they are not competent enough to continue making decisions regarding our children's health and welfare. In addition, school districts would be required to spend money on a curriculum similar to the one provided by Planned Parenthood, including the money spent for training and materials. The school districts are already struggling to provide a quality education with a very limited budget and the State of Alaska is not going to offset the cost of revising the curriculum with additional funds.

Parents have always had the right to opt out or opt in when subjects they don't want to see their children taught. As a parent of five, two out of five children were homeschooled due to overcrowding and drugs, not sex education. There was even a point in time when children in other states would be pulled by social services because they didn't attend public school but were homeschooled. It was deemed as neglect. Alaska did not follow in other states' footsteps but made it an option for children to be homeschooled. It is still an option just

as private schools. Public school is just that – public. If a family is not happy with the curriculum then they have options such as homeschool, appealing to their local schools or school districts. This matter is only before the legislature because of Roe v. Wade and what has happened since.

To the members of the House Health and Social Services Committee

My name is Marjie Richards. I have lived in the Fairbanks area for over 35 years. I am a Registered Nurse. I am on the board of the Resource Center for Parents and Children, which provides parent education and houses Stevie's Place, where we provide forensic interviews and medical exams in a child-friendly setting when there is reason to believe a child has been sexually abused. Having worked in the past with an OB/GYN provider, I can tell you first hand it would be better if no one had an unwanted pregnancy, got an STD, was sexually abused or needed an abortion ever again. But in order for young women and young men to make good choices in regards to their sexual health, they need education and resources from qualified professionals. (I would venture to say families do not provide the bulk of the education that young people need or hear.)

Alaska is a leader in sexual health ignorance since fewer than one quarter of Alaska secondary schools taught all of the recommended HIV, STD, and pregnancy prevention topics in the 2013-14 school year; *only students in three states had less access to this information*. Local communities and parents should have the right to invite trusted partners like Planned Parenthood into the classroom if they choose. Until the state steps up in providing medically accurate sexual health education to all students, communities will rely on Planned Parenthood to provide that information.

SB 89 goes too far in restricting medically accurate, evidence-based, nonjudgmental sexual health education, such as that provided by Planned Parenthood, to students in a state with an epidemic of sexually transmitted infections, as well as sexual abuse. The "opt-in" clause for parents will create an administrative nightmare for teachers and schools. There is already an "opt-out" option for parents who do not want their children to receive sexual health education in school.

This bill is obviously a politically motivated and legally questionable attempt to target Planned Parenthood at the expense of the health of Alaskan students. Our legislators should be focusing on improving students' health, not targeting providers of a legal and constitutionally protected service.

My name is Samantha Savage and I live in House District 5. I am writing today to voice my opposition of SB 89.

I live in Fairbanks, I love everything about living in the interior including our cold. However I don't think the legislature understands the endemic rates of reproductive health issues that plague my region, and our state. In 2014 our rate of Chlamydia infection was 778 persons per 100,000 statewide, and 759 person 100,000 in the interior. It is estimated that 49% of women in Fairbanks have experienced intimate partner violence in their lifetime, and 4% of women in Fairbanks have experienced sexual violence in the last year.

I grew up in Wasilla, the area in which the bill sponsors are from and graduated from Colony High school in 2011. While I had sex education that I can say was medically accurate, it was not comprehensive and many of my questions were left unanswered.

This bill asserts that Planned Parenthood is in schools with sinister motives. To say that Planned Parenthood is indoctrinating children is completely false, and the only interest Planned Parenthood has is a long history of being committed to teaching comprehensive and medically accurate sex education so that all youth have the opportunity to make important health decisions for themselves, and this bill while not getting rid of sex education this bill put unreasonable barriers in front of students.
