When it came, I balked at the \$10 Alaska School Tax deduction in addition to the SS tax. Although a very small amount, it was substantial portion of my meager paycheck. My mother told me to buck up and explained that this tax was only taken once per year from the first paycheck earned. She said we all needed "skin in the game" and that I in particular was benefitting from public education to which that tax went. That was my first lesson in the concept of the social compact from my devoutly Republican mother.

At just \$10, the tax yielded \$2.6 million of revenue in 1979. The school tax and the state income tax were repealed in 1980 with the flow of oil dollars to the state.

On behalf of the NAACP Tri-State Area Conference and in my role as Alaska Education Chair, I submit this letter in strong support of House Bill 152, sponsored by Representative Alyse Galvin and co-sponsored by Representatives Mina and Himschoot. This legislation represents a bold and necessary step toward ensuring Alaska's children receive the public education they deserve.

Alaska has underfunded its public schools for over a decade. Our current funding structure, which relies too heavily on political maneuvering and one-time patches, has failed students, families, and educators. HB 152 offers a long-overdue solution by creating a dedicated, stable source of revenue through a modest education tax one that prioritizes early education and K–12 public schools.

For far too long, we've heard elected leaders say they value education, but refuse to back those words with action. HB 152 puts action behind principle. It ensures that those with the greatest means contribute to the public good, while offering flexibility for Alaskans to use their Permanent Fund Dividend toward the tax if they choose. We can't recruit or retain high-quality educators without fair compensation and predictable funding. And we cannot close the achievement gaps that disproportionately affect Alaska Native, Black, and other marginalized students without robust, equitable investments.

HB 152 is not just a tax bill it is a values statement. It tells the next generation that their future is worth funding.

I urge you to move this bill forward and demonstrate that Alaska is ready to invest in its children, its communities, and its future.
