Analysis

HB 126 amends AS 10.06.960(k) to allow corporations organized as a Native village corporation that has been involuntarily dissolved and failed to reinstate with the period established in AS 10.06.633(e) to be reinstated under AS 10.06.633(e) on or before December 31, 2026, (rather than December 31, 2020, as the law currently reads).
Additional corporations filings would not impact the Division of Corporations, Business, and Professional Licensing (CBPL) corporations section. CBPL does not anticipate fiscal impact from this legislation.
Corporation filing fees are General Fund/Program Receipts fund source 1005 GF/Prgm (DGF). Corporation filing fees are set in regulation per AS 10 and 32. Revenue in excess of authorized budgeted expenses reverts to the general fund.
