Dear Senators and Fellow Alaskans,

As a Title I secondary school educator in Anchorage for 18 years, I have sadly been witness to what can only be described as a gradual deterioration of our public school system, and the worst part is that it is impacting the children who most rely on a quality education. Over the last eight years, the pupil-to-teacher ratio in my classroom has increased by 20% (resulting in my average class size being 32 students), ancillary positions from English Language Learner counselors to technology support have been cut, and there has been a shocking exodus of staff who have left state or the profession altogether.

In the face of such diversity, I have been humbled by the job that my school continues to provide. There are truly great things that are happening in our school. Despite these efforts, however, continuing in this manner is not sustainable, and the cracks are beginning to show. We were unable to fill five full-time positions with certificated staff. For the first time ever, we needed to recruit teachers on J-1 visas and allow student teachers to take on emergency teaching responsibilities. These educators show promise, but they are simply not as capable as a veteran educator.

The proposed cuts for next year go beyond anything our society should ever be okay with. There is most certainly a point when not only will the quality of education suffer, but I start to wonder whether schools can actually keep their kids safe. The fact that my school has seen a reduction in staff of about 25% over the past eight years means there are that many less adults monitoring the lunch room, the hallways, and the playground.

A substantial increase to the BSA is needed. Every single one of us would struggle if we were expected to live off the same income that we had in 2015 given the high costs of inflation, yet that is exactly the position our districts are in. Further, one-time funding is causing too many problems for districts who are having to lay off the very educators that we hope will be around for 20 years or more. We need a long-term solution and stability in our state's model for funding education. Please support HB69 and do what is right for kids.

We are in a vicious cycle of underfunding, which directly impacts performance. This, in turn, doubles down on further reduced funding and lower performance. This is a downward cycle in which no one benefits and dramatically diminishes our children's opportunities.

The lack of BSA funding means schools will continue facing layoffs, program cuts, and operational challenges.

Dunleavy's education package ties targeted funding increases to specific policy changes rather than offering broad, sustainable funding for public education, and it falls short of addressing the real crisis facing Alaska's schools: chronic underfunding, inequities in resources, and an unprecedented teacher shortage. The proposed education budget will result in the elimination of a significant number of teacher positions, leading to class size increases, reduced course offerings, and reduction of sports and extracurricular activities that provide a valuable way for students to enjoy school, have well-rounded interests, and create a community at their schools.

The Alaska constitution requires that the legislature "establish and maintain a system of public schools open to all children of the state," the lack of adequate funding for our public education system for well over a decade does not carry out this mandate. Schools are closing, teachers are leaving the profession, families are leaving the state, and companies are having difficulties attracting talent because we have failed to invest in our kids and Alaska's future.

We deserve a public education system that provides our communities with a strong, stable, and non-polarization foundation. We all benefit from cross-cultural and cross-socioeconomic exposure that predominantly happens through our diverse public schools. Our communities need less polarization and segregation, which are only amplified through private and charter schools.

I would like to communicate as a parent of two children who will be in the ASD next year, that a bsa increase of A MINIMUM of \$1000 is required to keep our schools somewhat adequately running. After more than a decade of flat funding, I am highly concerned with the ability of asd to adequately educate our children. It is unacceptable to consider less funding and expect adequate education for the next generation. It is imperative for a healthy continuation of our community that we invest in our youth. Additionally it is a constitutional obligation to provide quality public education to all Alaskans.

Data shows money invested in good public education provides the following benefits:

1. Economic Growth and Productivity

- Increased GDP: A 2016 OECD report found that a 1-year increase in the average schooling level of a country's population can raise GDP per capita by 3-6%.
- Higher Individual Earnings: In the U.S., high school graduates earn about 25% more than non-graduates, and college graduates earn about 75% more than those with only a high school diploma (U.S. Bureau of Labor Statistics).
- Improved Workforce Skills: The World Bank shows that countries investing in education typically see improvements in innovation and adaptability within the workforce.

2. Lower Crime Rates

- Reduction in Incarceration: A study from the RAND Corporation found that high school graduation reduces the likelihood of incarceration. Dropouts are 63 times more likely to be incarcerated than college grads.
- Cost Savings: Every dollar invested in early childhood education returns \$7–\$10 in public savings through reduced crime, welfare use, and remedial education (Heckman Curve, economist James Heckman).


