I want to share the testimony I gave at the Anchorage School Board meeting last night. My kids attend a great optional school in Anchorage and the school is slated to lose two teachers next year if HB 69 doesn't pass with \$1000 increase to the BSA. This would be devastating for our school and the students who attend.

Here is my testimony from last night's school board meeting:

"Hello, and thank you for the opportunity to speak tonight.

My name is Rebecca Hills and I'm here to urge you to maintain all 11 teaching positions at Chugach Optional Elementary School.

You have already heard from Chugach students and parents about the exceptional nature of the program and the uniqueness of the experience it offers students. I am going to talk to you about the numbers and why the program that has been in place for 50 years is working and should be shared, so that more students can benefit.

I'm sure you know that Chugach students do well on achievement tests. In fact, Chugach is consistently in the top three or four elementary schools in the district for achievement. But let's break it down:

- Math (MAP Growth): Only 41% of ASD 6th graders score above the 50th percentile benchmark, compared to 74% at Chugach.
- Reading (MAP Growth): Just 47% of ASD 6th graders surpass the 50th percentile, while 93% of Chugach students do.

#### Dear Senate Finance Committee.

I am writing to implore you to pass a strong BSA of at least \$1000 and continue to fight for education funding into our future. My name is Katrina Hanger. I currently teach 5th grade at Ravenwood Elementary school in Anchorage, Alaska and I was among the many teachers recently displaced. I'm here to tell you about my experience with displacement at Anchorage School District and, from my perspective, the impact it's had on me, my family, our schools, and our greater community. Without a strong BSA, this will continue to be a reality for Alaskan teachers for years to come.

I'm an experienced teacher with over 15 years of teaching experience, I have my Master's Degree and my National Board Certification. I've worked in four different states and in 7 different schools. I've taught multiple grade levels, specialized in Title I and English Language Learners, and have taught in STEM magnet schools. In all of the various systems in which I've worked I've never experienced anything quite like the self-inflicted disruptive effect that our current method of displacement has on our teachers, students, and communities. This inefficient process is not without its consequences - and my anecdotal testimony tonight is just one teacher's example I hope might highlight some of the negative effects and unintended consequences.

My family and I moved to Anchorage three years ago. As a career educator, it should be no surprise that when we were choosing where to live we made that selection based, in no small part, on a school and community we felt would be a good learning environment and community for our three young children. My hope was to be able to teach in their school although I recognized that I might not be able to do that right away. So, I interviewed for schools in Northeast Anchorage hoping to reduce the amount of commuting time and work through various drop-off and pick-up schedules with children in school and daycare. My husband is a firefighter and isn't always able to be around for drop-offs and pickups either. For that year we had to pay for additional child care just for me to be able to work my normal hours as a teacher and then pick up my own children.

While I enjoyed my year working at Ptarmigan Elementary and built some strong relationships with the community and my colleagues, working far away from my young family was a challenge. My principal was very thoughtful and supportive about letting me flex my time to pick up my children from daycare, but I still wasn't able to commit fully to the school because of my responsibilities as a mother. I couldn't participate in after school activities and I often felt behind because I had to leave early to pick up my youngest son from daycare. I enjoy being a part of those after school activities and find that it helps in building relationships with students and building a better community centered around our childrens' growth and development.

In February I applied for a transfer to Ravenwood. I had a great interview but the principal needed to accept a displaced teacher during that hiring period and could not offer me a position since I was a voluntary transfer. I was delighted in July when I received a call that enrollment was very high and I would be able to join the Ravenwood team as a % combo teacher. Teaching a combo class is a very difficult job. You need to master two grade levels of standards and fit them all into a regular school day. I excitedly accepted the position though because it was my dream to work at Ravenwood and spend the waning years of my childrens' primary education being able to be with them as a teacher in their school. It's truly been one of the highlights of my life to be able to see my childrens' smiling faces in school and see how happy they are in the community Ravenwood has created. I want to be a part of making their school the best it can be - I have a vested interest in being a part of that and I have had the highest job satisfaction there as a result. I was able to stay late when I needed to because my children were with me. I committed to every after school fundraiser and joined several



My name is Meghan Redmond. I am the principal of Homer Middle School in Homer, Alaska, but I am also a parent of 4 young children that I want to have the best future possible. I have been a teacher, assistant principal, and principal both on and off the road system in Alaska for the past 15 years. I am writing today in support of HB 69. I am specifically asking for the \$1000 increase to remain in the bill.

Our schools are facing rapidly rising costs in energy, transportation, health care, food service, and so much more. As those costs that are mostly out of our control rise through the roof and our funding remains flat, our districts are forced to find cuts that directly impact the classroom through cuts in staffing. As a principal, when I have to cut staffing, I am faced with an impossible decision of what opportunities to cut for my students or how big to make classes. I am forced to make decisions that I know are not best practices for student learning, when my original plan for next school year was to be moving the completely opposite direction. I can speak from experience that the things everyone calls "extra" are most often the things that get motivate kids to get to school so that they can also get our core instruction.

We need stable, long term, and predictable funding for our schools to be able to focus on long term school improvement, and to retrain and recruit excellent educators to our schools. Being a teacher is hard, being a teacher in Alaska is even harder. We have amazing, dedicated teachers in our state. but when our jobs are constantly on the chopping block due to possible budget cuts that year after year are stayed off temporarily by one-time funding outside the BSA, eventually the amazing teachers we have will have had enough. And I can tell you from personal experience in hiring teachers in Alaska for the past 15 years that we will not be able to replace them.

Our teachers deserve reasonable job expectations. We constantly ask our schools and our teachers to do more and more with less and less every year to the point that being a teacher is an impossible job.

We need stable, long-term funding for our schools. This will make an immediate improvement in the education of Alaska's children.

Last year, you heard the public testimony and the stories. You worked together with the rest of the legislators and found a compromise that nearly ALL of you agreed to. Dear Members of the Finance Committee,

My name is Amy Rayess, and I am emailing to strongly encourage you to pass HB69 with a BSA of at least \$1000. It is time to invest in education, and the future of Alaska.

I am a parent to 3 daughters who will be in the Anchorage School District. We are incredibly happy with our lottery school, Chugach Optional Elementary. It is the kind of school I believe Dunleavy wants to see. Not only are our scores high, there is data to show growth across the board. About 4-5 dozen parents and students showed up to the ASD school board meeting last night to ask that we keep 2 teaching positions that are set to be eliminated next year. Our school is particular with an intentional structure of multi-age classrooms. We cannot just do a combo-class, like other schools might be able to, since Chugach has a 24 month curriculum per "family group" (the school's term for a classroom) with two grade levels. So we cannot just put 4 and 5 grades together, as the 4th graders would have missed 12 months of the curriculum. Our school is at 108% capacity. With the loss of two teachers our pupil to teacher ration would be 30:1. And, since we have multi-age classrooms, some classes will have more than 40 students. This is physically not possible and unsafe.

There has been a long history of success at Chugach Optional Elementary School. It's worked, it works, it's working. Not only are Chugach students high achievers, they demonstrate growth. Here's some data:

In the 2024-2045 school year, 43% of 3rd-6th grade students within ASD scored about the 50th percentile on the MAP growth Math test compared to 67% of 3rd-6th graders at Chugach. For the same time period, 50% of ASD students scored above the 50th percentile on MAP growth Reading test compared to 79% of Chugach students.

I come from a family of educators, and as a speech-language therapist with experience in the school systems. I know highly populated classrooms does not support student success.

My last point is that this is not just about education, it is also about Alaska's economy. I've testified before, that my family along with other families may be faced with a hard choice to leave Alaska if leaders continue to not support our children and their education. My husband is a child psychiatrist, and we both can find work elsewhere. His initial job that brought him to Alaska was looking for a child psychiatrist for 5 years prior to hiring him. Alaska will lose specialists, experts and will not be attractive to recruit professionals. Not to mention teachers! Who would want to continue the time and effort of being a teacher with such high class numbers, and with the district forced to make cuts every year. Something has to change. It's up to you, please stop kicking the can down the road. The time to act is now. So many folks showed up for the town hall meeting on Saturday. Hear our voices, be our leaders. Do what you need to do, a lower PFD is an option, taxes are an option. We are willing, please make the right decision for Alaska.

Just last year, one of our local school counselors moved into the private sector because her job wasn't certain either. As you discuss HB69 I urge you to keep the \$1000 BSA increase. This is a minimum that schools need this year. It's already been almost halved compared to the initial proposal that would have made up for lost buying power due to inflation.

I also urge you to find new revenue sources. Adjust the S-Corp tax for large companies. Create an income tax - we've had one before and it was short sighted to eliminate it. Reduce the PFD pay out. As evidenced by the past couple of days, oil prices are volatile which makes budget planning very difficult. We need to diversify our revenue sources.

I would even consider dipping into savings at this point, but I would much rather implement new revenue sources and reduce the pfd pay out before doing that.

Without a substantial funding increase my son has the potential to be in a class of 50 second graders next year. Without an increase my children's school will only have a half time nurse. Without an increase in funding my daughter won't have the opportunity to explore new sports in middle school, giving her less opportunity to develop life long healthy habits. Without stable funding we risk losing teachers every year.

Our children are the future of our state. They deserve an adequately funded public education system.

Dear members of the Senate Finance Committee,

Thank you for your service to Alaska and for the critical work you are doing at a historically challenging time.

As an individual member of the Anchorage School Board and as its Treasurer and Finance Committee Chair, and with an awareness that you will hear HB 69 on Thursday, April 10th but not take public testimony, I write in strong support of HB 69—as most recently amended by your colleagues in the Senate Education Committee—and with an acute sense of urgency.

On March 31st, the Anchorage School District administration initiated the backwards-planning process required to navigate its May 15th contractual deadline to lay off teachers in alignment with the balanced FY26 Budget the ASD Board passed on February 25th, 2025. Although this was delayed as long as possible, and although anticipated retirements and resignations have offset some of the District's need to issue displacement notices, the District nevertheless notified nearly two hundred educators that they will be displaced from their current position for the 2025-26 school year last week.

Students, their families, and our educators are reeling as programs are poised to end and students' opportunities to play sports, pursue fine arts, study foreign languages, take AP classes, enroll in high-demand CTE coursework, and more will be reduced and/or eliminated.

The process had to be initiated, however, because ASD's balanced FY26 budget was due to the Anchorage Assembly at the end of February. To balance its budget based on existing statute, which has not been adjusted for inflation since the 2010-11 school year, the **Board cut ASD's administrative costs**—which are already among the leanest in

the State—by \$8.7 million¹ and voted to suspend Board Policy in order to spend its unrestricted Fund Balance down to 5%, rather than maintain it at 8%, so as to minimize classroom cuts to the greatest extent possible.²

But even with its overreliance on Fund Balance and its administrative reductions, ASD's budgetary "efficiencies" could not offset an \$111 million structural deficit without also **substantially increasing K-12 class sizes and eliminating programs and opportunities for students.** That's why cuts to kids and classrooms next year are poised to span everything from summer school, Battle of the Books, Middle School sports, and high school hockey, swimming, and gymnastics, to the IGNITE and immersion programs, as well as students' access to nurses, librarians, reading specialists, holdback teachers, principals, counselors, and more.

For a granular understanding of how **ASD's FY26 Budget will impact classrooms in every school in the Anchorage School District,** I urge you to review "FY26 Elementary Classroom Teachers.pdf" and "FY26 Secondary and Alternative Teacher Staffing.pdf," both of which are attached, which the ASD Board reviewed during its February 2025 Finance Committee meeting.

As the screenshot below indicates, these charts compare enrollment-based staffing levels as well as the "holdback" teachers used to address unexpected enrollment bubbles wherever they may emerge at every ASD school this year (FY25) with enrollment-based staffing levels for next year (FY26), based on the adopted FY26 Budget "Pupil Teacher Ratio" (PTR) increase of +4 across the K-12 system. The last column in each of these pdfs highlights the number of classroom teaching positions which will be eliminated at every school next year if ASD does not receive a \$1,000 increase to the BSA prior to May 15<sup>th</sup>.

Because two members of this Committee are from Anchorage, it may be appropriate to point out what these cuts will mean in *some* of their schools. While more than 11 positions will be cut between Chugiak and Eagle River high schools, another 8.5 positions will be eliminated between Gruening and Mirror Lake middle schools. Across town, Hanshew Middle School will lose 9 educators while Service High School will lose 8.9.

But the changes at those six schools are a drop in the proverbial bucket: all told, **ASD's FY26 Budget eliminates 357 full time school-based staff reductions.** Although 69 of these reflect predictions for next year's slightly lower enrollment needs, the remainder ARE very much needed, and their loss reflects the combination of next year's pupil-



teacher-ratio increase and the additional layers of programmatic & staffing cuts which are being used to balance the budget.

I write to you because I believe that the Senate Finance Committee is poised to help change this trajectory. As outlined via the Jacobs/Lessens Amendment the ASD Board passed on February 25<sup>th</sup> (which is also attached for your reference; see especially page 3), your support of the \$1,000 BSA currently encapsulated in HB69 is poised to reverse those cuts, lower class sizes to levels last seen in the 2015-16 school year, and make critical investments in students aligned with the Board's adopted goals for reading, math and graduation rates. This is a promise and a plan which can be operationalized if your swift, supportive Committee action is followed by timely and necessary levels of support in the Legislature as a whole.

To that end, I wish to draw your attention to two final documents, "FY26 Classroom teachers @ FY16 PTR - Elementary.pdf" and ""FY26 Classroom teachers @ FY16 PTR - Secondary.pdf" which the ASD Board Finance Committee reviewed in March and which reflect next year's staffing plans, by school, if FY26 PTR levels were reduced to FY16 PTR levels. While still reflecting enrollment projections, the last three columns in these two documents highlight the school-level impacts that a \$1,000 increase to the BSA would have via the reduction of PTRs to FY16 levels, the additional staff which will be required to reach those lower PTR levels, and the total number of classroom teaching positions which each school would offer next year.



For the past four years, it has been my honor to have served as the Treasurer and Finance Committee Chair of the Anchorage School Board. This role helps me understand the gravity and significance of your own work on the Senate Finance Committee. **And so it is with the greatest degree of respect and appreciation that I urge your support for HB 69,** although I would be remiss if I did not also emphasize that a \$1,000 increase without a plan to address inflation will present significant hurdles in less than a year's time, when ASD must pass its FY27 budget.

# Jacobs/Lessens Amendment 1: Attachment A AMENDMENT TO ASD MEMORANDUM #096 (2024-25): Fiscal Year 2025-2026 Preliminary Budget

Add the following language to ASD Memorandum #096, and include Attachment A as guidance from the Board to the Administration to amend the 2025-26 (FY26) Financial Plan and Budget once the Alaska Legislature successfully increases the Base Student Allocation as detailed below.

The Anchorage School Board intends for the Anchorage School District's 2025-26 (FY 26) Budget to provide the best possible learning environments for all students and to support adopted Board goals for 3rd Grade Reading Proficiency, 8<sup>th</sup> Grade Math proficiency, and high school graduation rates.<sup>1</sup>

Earlier this winter, the Anchorage School Board and Anchorage Assembly asserted their joint support for a substantial State investment in public education which would, at minimum, adjust the Base Student Allocation to account for inflation since 2010-11 (FY11).<sup>2</sup> According to the State of Alaska's Legislative Finance division, that amount has been calculated to be \$1,808 for the 2024-25 school year (FY25).<sup>3</sup>

If the Legislature were to successfully amend AS 14.17.470 so as to increase the Base Student Allocation by an amount no less than \$1,000, this action would generate a minimum of \$71.1 million in new revenue for the Anchorage School District.<sup>4</sup>

What follows is a commitment to applying this revenue in alignment with adopted Board Goals, Board Policy,<sup>5</sup> and in support of class size reductions and the retention of effective and valued programs. These actions would align with desires articulated by members of the Anchorage

Legislative Delegation and discussed as a prerequisite for supporting a permanent increase to public education funding in this amount.<sup>6</sup>

Therefore, should the Legislature approve a permanent statutory increase to the Base Student Allocation of \$1,000 prior to the Anchorage School District Administration's May 15, 2025 deadline for issuing required layoff notices, the Anchorage School District Administration shall amend the 2025-26 (FY26) Financial Plan and Budget by making the investments detailed in Attachment A.

Should the Legislature approve a permanent statutory increase to the Base Student Allocation of greater than \$1,000 and thus the \$71.1 million noted here, the Board will strategically align additional revenue towards further reductions in class sizes.




