Dear Honorable Alaska Representatives,

I write to express Native Movement's support for HB 125, which provides for subsistence user representation on the Alaska Board of Fisheries. Native Movement is a statewide non-profit organization dedicated to building people power, rooted in an Indigenized worldview, toward healthy, sustainable, and just communities for all.

Native Movement supports HB 125 because it guarantees that at least two members of the Board of Fisheries will represent subsistence users. For thousands of years Alaska Native peoples have stewarded these lands and waters through traditional practices now known as subsistence. The traditional knowledge subsistence users bring with them is critical to managing Alaska's fisheries sustainably. This voice has too often been shut out of the decisionmaking process, to the detriment of Alaska's people and resources. To create balance in our natural systems it is imperative that traditional hunters and fishers have a seat at the table.

We hope HB 125 is a first step in a larger, long-term process of integrating Alaska Native knowledge and practices into State-level decisionmaking. All of Alaska stands to gain from the wisdom subsistence users have accumulated over thousands of years of living on these lands.

Dear Representatives Burke and Dibert and committee members,

United Southeast Alaska Gillnetters are opposed to the current version of HB 125. We feel the current statutory standards are sufficient to allow the governor to appoint an objective fair-minded board.

We believe designated seats will formalize divisiveness at the board level. The Board of Fisheries is already that way, and it will worsen and allow for triangulation that will be the demise of the odd user group who is out. We believe that having a formal designation will result in those seats always voting the way of their seat designation, rather than in the best interest of the State.

We don't believe that a scientific seat is necessary. The Board gets guidance from the Alaska Department of Fish and Game. Any other scientific data is admissible in the process by proposers and stakeholders for the Boards consideration. The requirement of a scientific degree would limit the pool of resources the governor could choose from.

While we certainly understand the frustration with the Board of Fisheries process, as it can be unpleasant and arduous, we don't believe this bill will change it for the better. In fact, we believe it will make it worse. Over the years we have heard complaints of a commercial interest friendly Board, while we were complaining about a sport interest friendly Board. Both can't be true, so

either someone is lying, or their perceptions are correct, and the process is working as it should. There should be no champions for any user group, if the interest is for the best for all.

Currently, any Alaskan can submit their name for the Board, and anyone can support them for appointment. We think this works, and any changes made to the make-up of the Board can be made at the governor level, using the statutory guidance that is currently in effect. We have participated in meetings for years, and what we like to see in a Board member is intelligence, an open mind, and diligence to the process. They need to have the ability to learn about all the subject matter presented, and to disseminate the information. They should be accessible at meetings to stakeholders, regardless of whatever bias they have. Bias is inherent to the species, but a person with sound reasoning should be able to look past it. A broad background with at least a familiarity of commercial fishing, sport fishing and subsistence, with an expertise in at least one would be helpful.

We see this bill as advocating for agendas. Agendas are for proposers and stakeholders, not Board members. As ugly as the process can be at times, we will say it is a very unique process that has an immense value to the stakeholders in this State, and no steps should be taken to diminish it, as this bill would.

We appreciate your consideration of our opposition to HB 125.

Our mission is to maintain and promote a strong regional organization supported by the Tribes of Bristol Bay to serve as a unified voice to provide social, economic, cultural, and educational

opportunities and initiatives to benefit the Tribes and the Native people of Bristol Bay.

Pilot Point We are concerned about House Bill 125, and must respectfully oppose it as written.

The governor shall appoint the members as follows:

(4) one member who represents the scientific community, from a list of three names submitted by the National Oceanic and Atmospheric Administration; however, the governor may reject the list and request that another list be submitted.

BBNA respects the Alaska Federation of Natives (AFN) and the National Oceanic and Atmospheric Administration (NOAA). However, BBNA, to be true to its own mission statement and to its Tribes, does not want to surrender any power to nominate a member who represents subsistence fishing, or any power to nominate a member of the scientific community.

We respectfully ask that Governor Dunleavy and the Alaska legislature amend HB 125 as follows:

- (3) two members who represent subsistence fishing-
- (4) one member who represents the scientific community-
