Dear Chair Carrick and Members of the Committee,

Thank you for taking public testimony on HB 152: Public Education Tax. My name is Evelynn Trefon, and I live in Newhalen, Alaska. I write to you today on behalf of myself and my family.

I was deeply disappointed that the veto of HB 69 was not overturned last week. During discussion, it was stated that the override could not be supported due to the state's significant budget deficit. I agree that our fiscal situation is serious, and that's why I fully support HB 152 as a responsible way to create a dedicated funding stream for public education. We can no longer depend solely on oil tax revenue to meet the growing needs of our state. Draining our savings is not a sustainable or prudent path forward.

Since 2016, my community has felt the deep impact of statewide budget cuts. We've lost our trooper post. Our school year was reduced by 20 days. We lost our school counselor. Volleyball and basketball jamborees have been cut. We have a long list of deferred maintenance needs. All library staff and funds for new books have been eliminated. Our PFDs have been capped. Our school playground is over 20 years old and in need of replacement. And now, we face the end of LIHEAP and threats to Medicaid, SNAP, and other critical programs rural Alaskans rely on.

In August, our school district made the difficult decision to end the school breakfast and lunch program beginning January 2025 due to the inability to cover the USDA reimbursement shortfall. Like the State of Alaska, our schools have a revenue issue—but unlike the state, our schools cannot generate revenue on their own.

HB 152 presents a targeted solution: a revenue measure specifically dedicated to supporting public education. It's easy to oppose taxes. It's much harder—but far more courageous—to say, "We need to fund our schools, and this is how we do it." I respectfully urge you to take the hard road and vote in support of this bill.
