FISCAL NOTE ANALYSIS

STATE OF ALASKA 2025 LEGISLATIVE SESSION

BILL NO. SB147

Analysis

SB 147 will allow pharmacists who are under a collaborative practice agreement with a practitioner (that is not another pharmacist) to expand their patient care services by prescribing and administering prescription drugs and devices, including controlled substances.

If the bill passes the following expenses will be incurred:

Services: \$30.0 Legal costs related to investigations in FY2026 and beyond

\$5.0 Legal costs to amend regulations in FY2026 only

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services, fund source 1156 Rcpt Svcs (DGF). Per AS 08.01.065, licensing fees for each occupation are set so the total amount of revenue collected approximately equals the occupation's actual regulatory costs.
