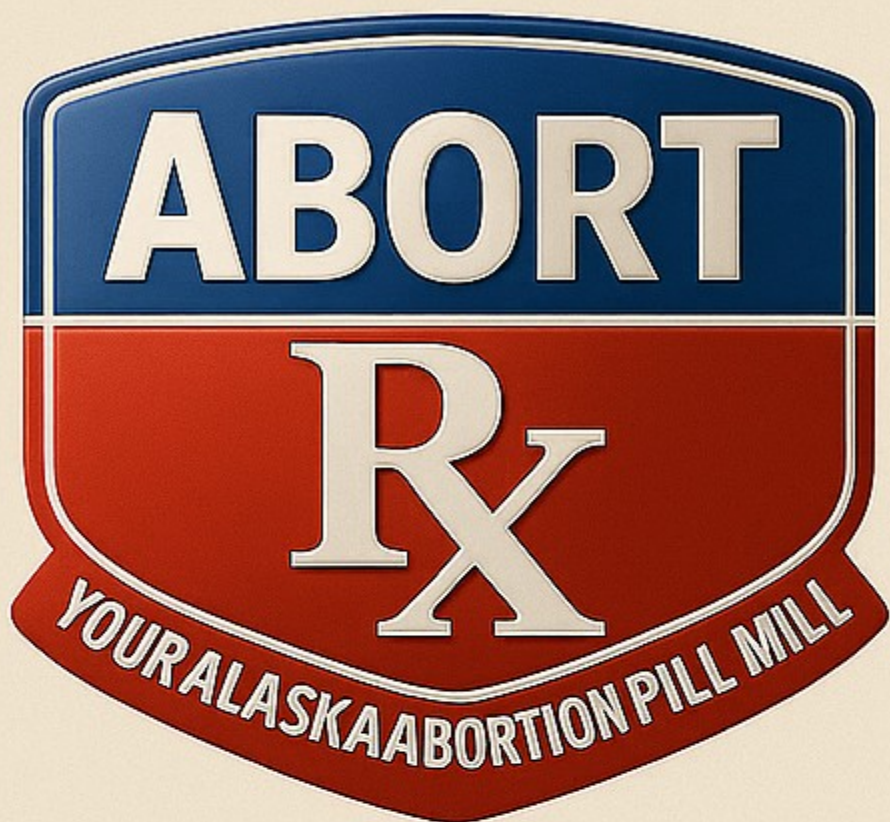

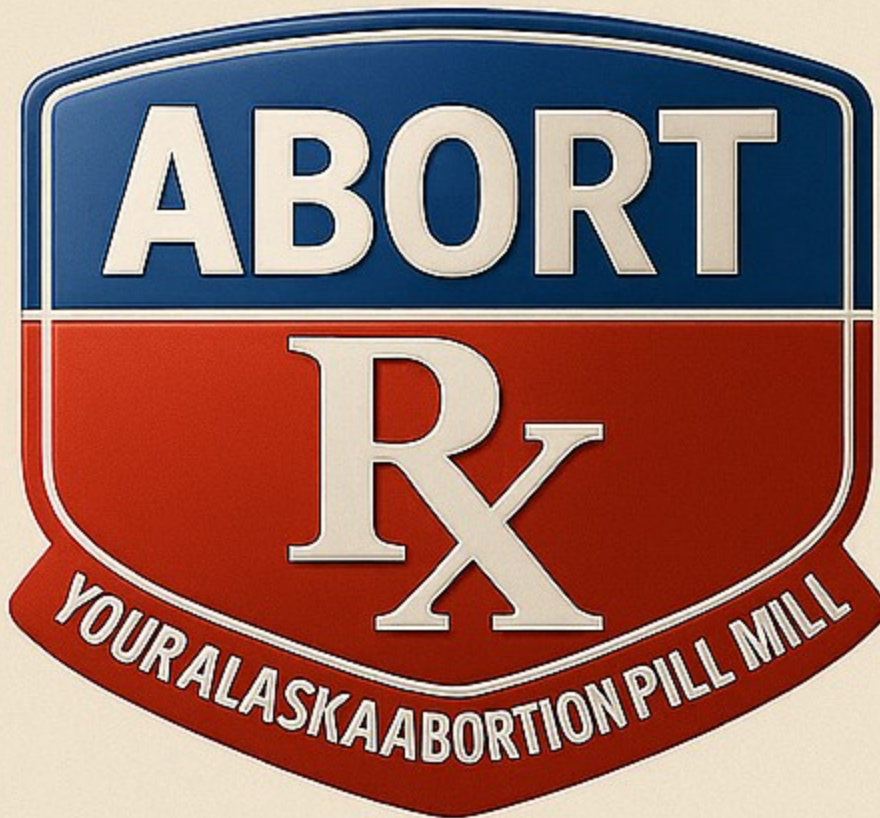

Although we agree with giving pharmacists greater freedom to assist patients without involving physicians, SB 147 needs to make it clear that that doesn't include pharmacists prescribing and dispensing chemical abortion medication.

Suggesting pharmacists should dispense chemical abortion medication goes against Alaskan law. AS 18.16.010(a)(1) provides that only licensed physicians may perform abortions; AS 18.16.010(a)(1) has always been interpreted to prohibit the sale of the abortion pill mifepristone directly to patients. Thus, pharmacist privileges drawn from SB 147 do not and should not include mifepristone (a chemical abortion medication).

In addition to the legality, there is a significant safety issue. I recently read that, "Today at 1:30pm, the Alaska Senate Labor and Commerce Committee will hear invited testimony for a bill ([SB 147](#)) that opens up the ability for pharmacists to prescribe and dispense abortion pills. Although there may be some merit to giving pharmacists greater freedom to assist patients without engaging physicians, **the bill needs to clarify with certainty that that doesn't include chemical abortion medications.**

Senator Cathy Giessel, the bill's sponsor, has argued that pharmacists are already prohibited from prescribing and dispensing abortion medication under current [Alaska statute](#), but that is likely incorrect. Chemical abortions are considered a prescribed medication and not a procedure. The current language of the bill is written to amend the term 'patient care services' to include the 'prescription or administration of a drug or device to a patient...'

This bill comes on the heels of a [critical study](#) using insurance data that reveals more than 1 in 10 women who take the abortion pill experience serious complications including hemorrhaging, infection, and sepsis—a statistic significantly higher than what the FDA has disclosed to the public.

A [study from the Ethics and Public Policy Center](#) analyzed data from over 865,000 prescribed mifepristone abortions, and found that the actual complication rate stands at 10.93%, which is 22 times higher than the 'less than 0.5%' figure reported in FDA-approved clinical trials.

How many women from Alaska were told mifepristone abortions were safe but ended up with serious complications? In fact, if we apply the 10.93% complication rate to Alaska's number of women who had chemical abortions (56% of 1,222), we could estimate that 75 women had some sort of complication. That doesn't reflect a "safe" abortion method. And in every case, an innocent, unborn Alaskan perished."

**While** pharmacists have excellent knowledge and skill regarding drugs, it has been my experience that they do not have the time to evaluate patients and determine if an abortion pill is safe or appropriate for a particular patient. To ask them to do so puts them in a bad position if/when something goes wrong. This is true for all drugs which is why a prescription is required in the first place.

As a former itinerant public health nurse, I worked in more than 60 villages. That was many years ago and much has improved in health care delivery since then. Other factors have remained just as potentially dangerous, chiefly the weather. If a village woman has an untoward reaction to the abortion pill, perhaps hemorrhaging, her chances of survival are greatly diminished if the weather does not allow a med evac. If she has obtained the medication without the knowledge of her local medical provider or the larger medical provider, she may hesitate to seek help in a timely manner. An urban patient may be of lower risk in this regard, but may still face hurdles in seeking care.

Who will be considered liable for the 10% of patients who experience an adverse reaction? for a death? The pharmacist, especially via telehealth, can only take the patient's word, not her blood pressure, not any lab test results, not her medical history.
