### Explanation of Changes CS for Senate Bill 64 (FIN)

Version 34-LS0153\W to 34-LS00153\L

- Title:** Removes references to financial disclosures, adds references to voter registration on PFD applications and the duties of the commissioner of revenue.
- Section 1:** Clarifies language around residency requirements.
- Sections 2 – 3:** Previous section 2, deleted. Previous sections 3-4 renumbered.
- Section 4:** Previous section 5, updated to clarify the information the Department of Revenue can provide as it relates to voter registration and voter list maintenance and provide a report to the legislature.
- Section 5:** Previous section 6, updates time frame of voter participation in this section from two general elections to 28 months.
- Sections 6 – 8:** Previous sections 7 – 9, renumbered.
- Section 9:** Previous section 10, updates audit to occur annually instead of biannually and conforming language.
- Section 10:** Previous section 11, renumbered.
- Section 11:** New section. Requires the division to inform the public when a data breach occurs.
- Section 12:** Simplifies the list of entities a rural community liaison collaborates with.
- Sections 13 – 17:** No change.
- Section 18:** Makes the requirement to provide language assistance at polling places to the extent practicable.

<b>Section 19:</b>	Changes the date a document a voter provides as proof of identification and residence from one within the past 90 days to 60 days.
<b>Sections 20 – 23:</b>	No change.
<b>Section 24:</b>	Changes may to shall as it relates to adopting risk limiting procedures.
<b>Section 25:</b>	Previous section 25, deleted. Previous section 26, renumbered.
<b>Sections 26 – 28:</b>	Previous sections 27 – 29, renumbered.
<b>Section 29:</b>	Previous section 30, Conforms to change made in section 19.
<b>Sections 30 – 33:</b>	Previous sections 31 – 34, renumbered.
<b>Section 34:</b>	Previous section 35, Conforms to changes made in section 19.
<b>Sections 35 – 36:</b>	Previous sections 36 – 37, renumbered.
<b>Section 37:</b>	Previous section 38, specifies that ballot tracking software, if procured, must come from a corporation incorporated in the United States and use multi factor authentication.
<b>Sections 38 – 47:</b>	Previous sections 39 – 48, renumbered.
<b>Section 48:</b>	Previous section 49, deleted. Previous section 50, renumbered.
<b>Section 49 – 52:</b>	New sections. Requires PFD applications online and hard copy to include prominently information on opting out of registering to vote, and to provide information on how the department of Revenue shares certain information with the Division of Elections for the purpose of voter registration and voter roll maintenance.
<b>Section53:</b>	Previous section 51, renumbered.
<b>Section 54:</b>	Previous section 52, renumbered. Additional statute added to repealer.
<b>Section55:</b>	Previous section 53, renumbered.
<b>Section56:</b>	Previous section 54, renumbered. Updated references to bill sections.
<b>Section 57:</b>	Previous section 55, renumbered.
