3 **** Section 1.** The uncodified law of the State of Alaska is amended by adding a new section
4 to read:

5 LEGISLATIVE INTENT FOR REPEAL OF AS 45.50.471(b)(52). With regard to the
6 repeal of AS 45.50.471(b)(52) by sec. 86 of this Act, it is the intent of the legislature that

7 (1) the repeal is to prevent liability under AS 45.50.471 - 45.50.561 for
8 conduct that violates AS 06.60, as amended by this Act, but that does not affect borrowers or
9 potential borrowers;

10 (2) a person, including existing licensees under sec. 87 of this Act, who is
11 required to be licensed under AS 06.60, as amended by this Act, and who engages in conduct
12 prohibited by AS 45.50.471 - 45.50.561 remain subject to the provisions of AS 45.50.471 -
13 45.50.561, including the provisions for private and class actions under AS 45.50.531; and

14 (3) the repeal not limit or prevent an action by the attorney general, or by
15 another person or class of persons, based on AS 45.50.471."
