FISCAL NOTE ANALYSIS

STATE OF ALASKA

BILL NO. CSSB 10 (FIN) AM

Analysis

This bill establishes a grant program to be administered by the Alaska Commission on Postsecondary Education (ACPE), which provides essential workers with tuition and fees to attend certain postsecondary institutions. The bill provides for various eligibility criteria for award of an initial grant and identifies eligibility criteria to receive a grant for another term. Total amount of grants may not exceed \$2,500.0 per fiscal year with prioritization for payment of grants if insufficient funds are appropriated. Additionally, the bill defines “essential worker” and establishes guidelines and a timeframe for a report on the new program to the Legislature. This act is repealed June 30, 2025.

As COVID-19 continues to affect businesses and Alaska’s economy negatively, this bill would support essential workers who are working currently or who were laid off temporarily or permanently during the federal public health emergency by offering grants for tuition and fees to attend state-supported educational institutions to improve their opportunity for employment.

In accordance with AS 14.42.170, the employees of ACPE shall serve as staff for the Alaska Student Loan Corporation (ASLC). As an enterprise agency of the State of Alaska, ASLC funds the positions and related work of ACPE through ASLC Receipts. Since these new duties associated with the essential workers grant program are not associated with ASLC, they must be funded through a different fund source.

Assumptions to implement the grant program outlined in this bill:

- Assumes grants and operating costs would be funded through Unrestricted General Funds (UGF).
- Services costs for FY2023 represent the cost for 1.5 FTE Financial Aid Operations Analyst/Financial Aid Specialist to oversee implementation and process awards and communicate with students and schools and Information Technology staff to support system setup and implementation. Total: \$187.5 UGF.
- Services costs for FY2024 and FY2025 represent the costs of .6 FTE Financial Aid Operations Analyst/Financial Aid Specialist to administer the program. Total: \$63.2 UGF.
- Services costs do not represent new positions, but reflect new duties to implement and administer the Essential Workers grant program. The Governor's FY2023 budget includes \$187.5 ASLC Receipts for these positions to be funded from ASLC. This fiscal note reflects a change in funding source to support the new duties of these positions. For the fiscal years FY2024 through FY2025, the ASLC Receipts are added back to reflect the shift back to providing services for ASLC.
