STATE OF ALASKA 2025 LEGISLATIVE SESSION

BILL NO. HB 197

Analysis

HB 197 introduces an executive administrator to the Alaska Board of Dental Examiners. This legislation is necessary due to the board's size, the high volume of licenses, permits, certificates, and endorsements issued, the complex requirements for sedation permits, and the ongoing research related to dental practices.

If the legislation passes the following expenses will be incurred:

Personal Services:	\$175.0	One full-time Executive Administrator, range 23, located in Juneau.

Services: \$25.0 Annual statewide and allocated core services for one position.

\$4.1 Department of Law regulations review in FY2026 only.

Commodities: \$10.0 One-time setup costs for equipment and space in FY2026 only.

\$2.0 Ongoing supply and equipment costs.

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services, fund source 1156 Rcpt Svcs (DGF). Per AS 08.01.065, licensing fees for each occupation are set so the total amount of revenue collected approximately equals the occupation's actual regulatory costs.
