KNOW YOUR CUSTOMER (KYC):

On the Confirm Your Identity step of registration, players will need to provide the following to create their account:

- Legal First Name
- Legal Last Name
- DoB
- Last 4 SSN
- Home Address

Player information is validated using a variety of licensed identity verification vendors including LexisNexis, Socure, and Aristotle who are trusted solutions for identity verification. In order to establish a DraftKings Sportsbook account, all players are required to verify their identity. If one of the listed identity verification providers is unable to resolve player PII to a valid identity, players are required to complete a real-time driver's license authentication check.

ENHANCED DUE DILIGENCE KYC - Threatmetrix:

Once a player has successfully passed the data accuracy check, our platform will initiate the “ThreatMetrix” process. This is a passive authentication that binds the verified PII from the data accuracy check to the phone number & device being used to create the account. If ThreatMetrix can match the PII to the phone & device being used, the player will be allowed to complete registration. If not, the player will move on to one of our other enhanced due diligence checks, knowledge base authentication.

ENHANCED DUE DILIGENCE KYC – Knowledge Base Authentication (KBA):

If a player does not pass ThreatMetrix check, they will be prompted with three Knowledge Base Authentication (KBA) questions to answer. If the player successfully answers the three questions, they will be allowed to continue with their account verification. If the player fails KBA, they're required to scan their driver's licenses for authentication and or manually upload documents for our customer service team to review.

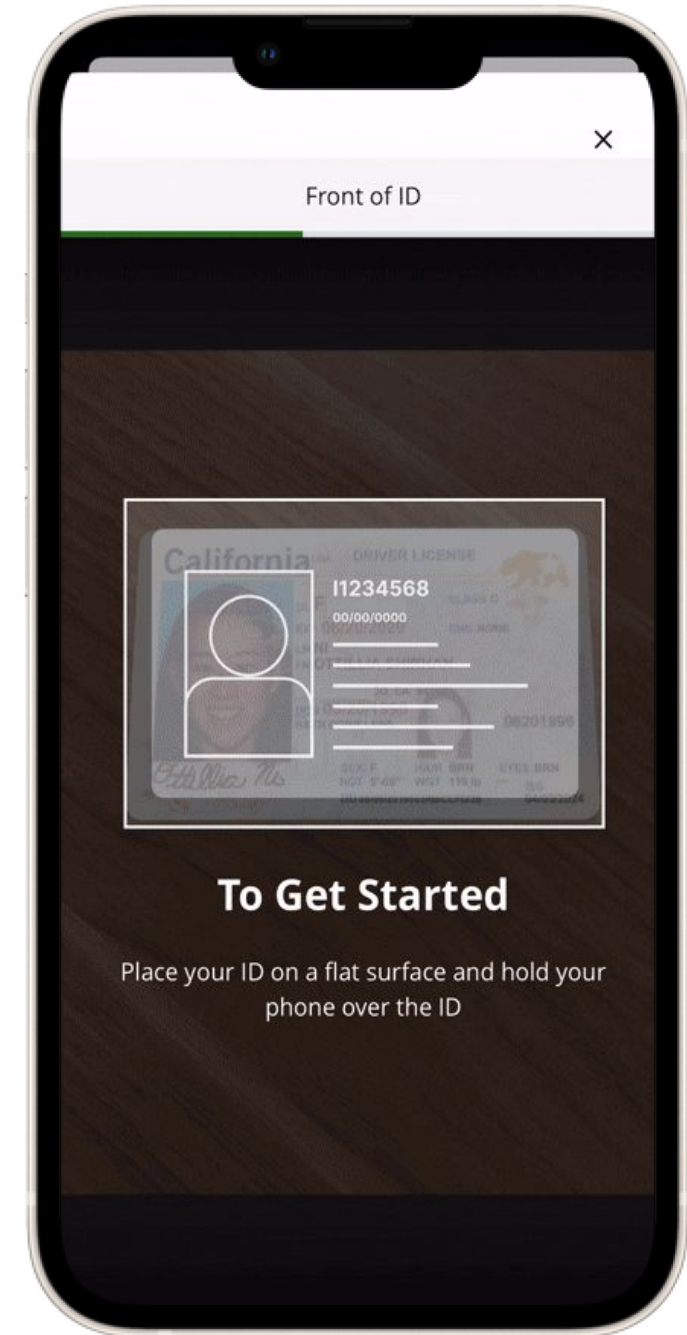

ENHANCED DUE DILIGENCE KNOW YOUR CUSTOMER - DocScan:

If the player fails knowledge base authentication (KBA), they're required to scan their driver's licenses via Socure DocScan for authentication and or manually upload documents for our customer service team to review.


If Socure determines that the driver's license is valid & authentic, DraftKings will extract the personally identifiable information (Name, DOB & Address) from the approved DocScan and require the player to resubmit their full 9-digit SSN. Once the player has provided their full 9-digit SSN, DraftKings sends that information to a full-service identity verification provider (e.g. LexisNexis) for an authoritative KYC decision to determine player eligibility.



AGREEMENTS AND RESPONSIBLE GAMING (RG) ATTESTATION:

After a player completes registration and is verified, they will then be prompted to acknowledge/accept the required agreements, and be presented with an RG Attestation that educates the player on our Responsible Gaming tools available.

After the required agreements are accepted and the player views and or takes action via our RG Attestation, they will then have completed account registration and verification.



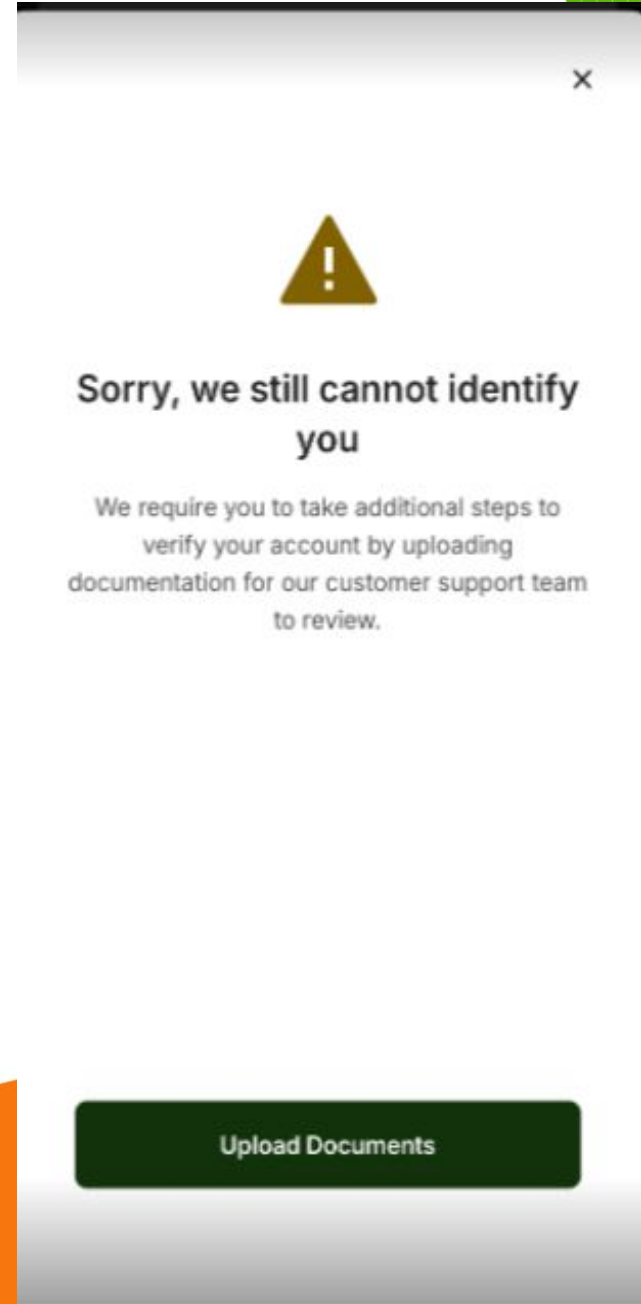


ENHANCED DUE DILIGENCE KYC - DocUpload:

If the player does not pass any of our first three Enhanced Due Diligence methods (ThreatMetrix, KBA, DocScan), the player will be prompted to manually upload an image of their driver's license for our customer service team to review.



EXCLUDED PLAYER MATCHING

- Every identity verification request submitted is subject to a “Known Persons” check
- Known Persons are records stored in DK database made up of excluded patron records for each jurisdiction we operate in
- Based on regulations, we can support matching at:
 - SSN 9 Comparisons
 - Last Name + DOB + SSN4
 - Last Name + DOB

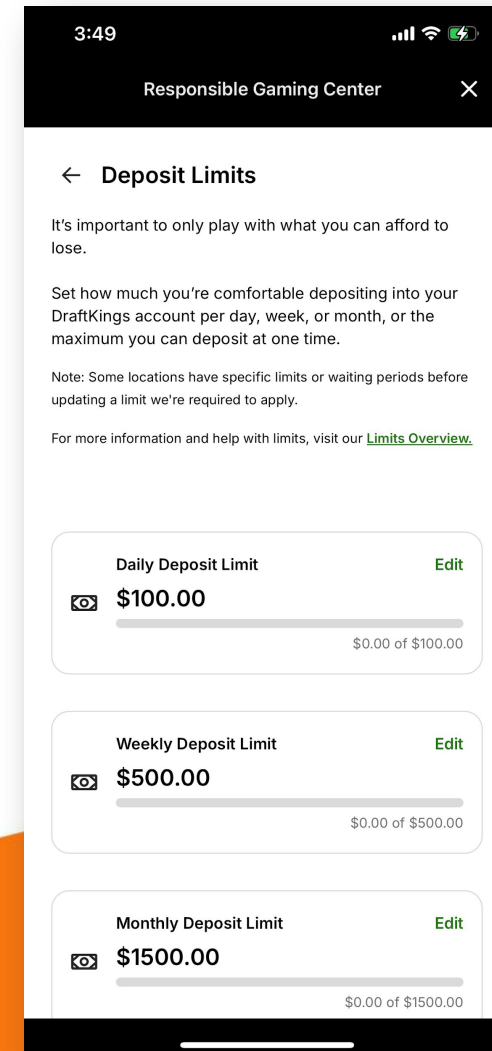
RESPONSIBLE GAMING (RG): PLAYER LIMITS

Responsible Gaming Controls

From account creation, to the moment a player gets their hands on winnings; our #1 priority is to make sure they're playing safely and responsibly.

- We provide players the ability to set the following self-imposed gaming limits
 - Deposit
 - Wager
 - Loss Limit Supported
 - Max Wager
 - Time
- We offer users the ability to enter exclusion programs & to set cool-off periods
- Participate in programs and initiatives to increase responsible gaming awareness.
- Prevent underage gaming.

My Stat Sheet

Launched in January 2025, allows players to see activity for: This Month, Last Month, This Year, Last Year, and Lifetime.

This is broken out by:

- Time spent
- Deposits
- Withdrawals
- Contest participation
- Wagers
- Net wins or losses

The goal is to inform and educate customers on their play with a direct link to the corresponding tools.

Nearly half of all DK customers have visited My Stat Sheet since it launched.
