**SUBJ:** Renewal No. 3 of the Lease Extension for Kodiak Office Space

The lease extension agreement between PS KFC Investments, LLC and the Legislative Affairs Agency for office space in Kodiak, Alaska, was for a five-year term that began November 1, 2018, and expired October 31, 2023. There are five lease extension renewals available under the lease agreement, each for a one-year period. We have exercised two of the renewal options.

Renewal No. 2 of the lease extension expires on October 31, 2025. The Legislative Affairs Agency would like approval to proceed with Renewal No. 3 for the period November 1, 2025, through August 31, 2026.

The Legislative Affairs Agency requests Legislative Council's approval to proceed with Renewal No. 3 for the period November 1, 2025, through October 31, 2026. If approved, two (2) one-year renewal options remain before a new solicitation must be issued.
