## FISCAL NOTE ANALYSIS

### Analysis

This bill amends law to allow provisions for School Board Members to serve as substitute teachers in their local schools. Additionally, this bill adds a requirement that School Board Members may not have been convicted of any felony crime under state or federal law, including a felony for which the person has been unconditionally discharged.

DEED will update regulation and policy to align with requirements of the bill, if passed. There are no fiscal impacts to DEED.
