FISCAL NOTE ANALYSIS

Analysis

This legislation requires the Alaska Housing Finance Corporation to adopt a state residential building code. It requires the examination for residential contractor endorsement applicants to include a test of the person's knowledge of that code to obtain a residential contractor endorsement.

The Division of Corporations, Business and Professional Licensing does not anticipate fiscal impact from this legislation.

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by receipt supported services, fund source 1156 Rcpt Svcs (DGF). Per AS 08.01.065, licensing fees for each program are set so the revenue collected approximately equals the occupation's actual regulatory costs.
