Analysis

Background and Summary

This legislation allows Alaskans who are eligible for the Permanent Fund Dividend (PFD) and file their application electronically to elect on their application to direct funds from their dividend payment to a newly established statewide spay and neuter assistance fund.

Contributions to Pick.Click.Give will be prioritized and paid before contributions to the spay and neuter assistance fund. The application would allow contributions in increments of \$50, up to the total amount of the dividend they are entitled to receive.

This legislation takes effect January 1, 2027.

Changes in Revenues

There are no changes in revenues as a result of the proposed legislation.

Implementation Costs

The electronic PFD application will need to be modified to include an option for Alaskans to contribute to the statewide spay and neuter assistance fund. There are one-time programming costs associated with the implementation of the proposed legislation which the division is unable to estimate at this time.
