When state-backed mega-projects fail or become boondoggles, the consequences do not stay isolated. They expose the state to financial risk, erode public trust, and tighten future budgets. In practice, those pressures fall hardest on rural communities and discretionary support for proven industries like tourism—industries that already operate with thin margins and limited infrastructure.

Rural communities like mine often bear the risk of these investment decisions without seeing the benefits. HB 124 is necessary to strengthen oversight, increase transparency, and reduce the likelihood that public funds are committed to high-risk projects that threaten broader economic stability.

For communities like Wiseman, responsible stewardship of public resources matters. HB 124 helps protect Alaska's proven industries and rural economies by ensuring development decisions are accountable, transparent, and grounded in clear public benefit.

As an Alaskan (based in Juneau), I was unable to make it to the public hearing today, but I wanted to submit comments via email in support of [HB 124: An Act relating to the Alaska Industrial Development and Export Authority; and providing for an effective date.](#)"

I'm deeply concerned with some of AIDEA's recent high-risk investments, the largest of which often focus on extraction projects or roads to potential extraction projects (West Su Access Road, Ambler Access Road, and Oil and Gas leases within the Arctic Refuge). Many of AIDEA's larger high-risk investments have been avoided by the private sector, which, to me, raises a major red flag.

I feel these high-risk investments are not a good use of Alaska's money, especially considering the budget crisis we are in. Additionally, investments in extraction projects aren't the investments I want to see made in Alaska. I love Alaska's public lands and waters. I want to see substantial investments in education, healthcare, job training, tourism, fishing, recreation, public safety, arts and culture, childcare, or even the PFD.

I recognize that AIDEA does some good work supporting small businesses, and I'm not advocating ending AIDEA completely. I feel AIDEA has little oversight, that leadership appointments are inherently political and come with an agenda (selected by the Governor), and that the board often dodges public accountability through executive sessions, and there is a lack of much-needed legislative oversight.

Something needs to be done, and HB 124 aims to take some key steps.

Please find attached House State Affairs written testimony on HB 124:

Good afternoon Madam Chair and Members of the Committee:

My name is Robert Sheldon, a lifelong Alaskan from Talkeetna where I reside. I have degrees in finance and economics which I have parlayed that into facilitating economic and business development at the high latitudes such as Norway, Iceland, Greenland, Canada and yes, Alaska. I work across private and public organizations including the military.

I've served Alaskans during the past 6 governor administrations on various boards and commissions requiring legislative confirmation. Public service is a priority to the Sheldon family, so it was my distinct pleasure to serve on the AIDEA board from 2010 into 2013.

If you want to stifle business, reduce partnering with the federal government and the military, then restrict AIDEA in its role, structure or capital.

Put another way, impairing AIDEA in any way will have an immediate detrimental effect to Alaskans of all walks of life and in all areas of the state.

Lets talk about that:

Many, many Alaska small businesses are grateful benefactors of the loan participation program that without it, they may not have a loan at all. And these businesses aren't poor credits ... Alaska suffers from scarcity of capital and that loan participation program makes sure many businesses receive critical liquidity for projects and such.

Which gets me to my favorite self-designed bumper sticker: Alaska is an emerging economy saddled with a mature bureaucracy, and that makes business very, very difficult here. I am talking about our phase of development where capital is scarce due to the low participation or attention of banks and a basically non-existent venture or private capital presence.

But its not just about small businesses.

In my time at AIDEA we advanced many large scale public good projects.

- + Fairbanks Interior Gas Utility (IGU) is one I'm very proud of. We not only are reducing energy induced poverty there, but also assisting with cleaning up the air thru reducing wood for heat use.
- + We also financed the National Guard Armory at JBER: It consolidated services with synergies for the State of Alaska (via the Department of Military and Veterans Affairs) and the Coast Guard, which also improved efficiency and readiness.
- + AIDEA acted as the issuer of \$123MM tax-exempt conduit revenue bonds for Providence Health & Services. The financing helped expand healthcare infrastructure in Anchorage, supporting long-term care options and upgrades to the acute care hospital. This solidly aligns with AIDEA's mission to promote community development, healthcare access, and economic benefits through job creation and improved services in Alaska.
- + We also renegotiated the PILT at RedDog mine with Teck, which pays for a huge chunk of education funding across that region.
- + We expanded the FedEx airport facilities which demonstrated to UPS they ought to do the same, and voilà, similar traffic continues to grow there since it was so well demonstrated by FedEx with AIDEA's participation.
- + And we made certain that SETS [Sustainable Energy Transmission and Supply Development Fund] was established. That 2012 act expanded financing tools for addressing the state's energy challenges. The program aims to -and has- promote lower-cost, sustainable energy statewide by leveraging public funds with private investment for projects that demonstrate financial and technical viability.
- + And finally, AIDEA provided a loan to AEA for the acquisition of the Sterling-to-Quartz section of a 115kV transmission line from Homer Electric Association. This supports transmission infrastructure tied to Bradley Lake hydro power, benefiting regional ratepayers and the Railbelt grid. That is the lowest cost power on the whole intertie, benefitting a very large portion of Alaskans.

In my experience across the high latitudes, if it were not for AIDEA, I am sadly very comfortable asserting that these projects would not have come to pass, at least not remotely in the timing and successful way that they did.

And remember, these efforts were just some from my time on the board from 2010 into 2013. The public good, specifically indirects, derived from AIDEA projects can be economically measured and reported. The 3.8% long term return cited earlier only measures a financial return and is probably far less than half the actual return.

I will now end with exactly how I began:

Impairing AIDEA in any way will have an immediate detrimental effect to Alaskans of all walks of life and in all areas of the state. I don't think anyone here wants to sign onto that.

Please do not cook Alaska's golden goose for some short term boost to another account which too, will soon be devoured.
