Hangar 1 needs a new canopy over the natural gas meter, mechanical room door and the exterior electrical panels. Hangar 2 needs a new canopy over the natural gas meter.</p> <p>Lighting: Install a middle row of LED shop lights in the parts stockroom of Hangar 1 equivalent to 50 to 70 lumens per square foot. Replace Hangar 1 lights over the main bay and zone the lights in both hangars so they can be turned off/on as needed. For repair or maintenance on aircraft, hangar lighting requirements are 50 to 100 foot candles. Replacing the lighting fixtures with high bay LEDs will result in reduction in electricity use, decreasing utility bills. Proper lighting is needed to continue work, and the LED option is more cost and energy efficient. Unfortunately, seventy percent of the state owned MF's are in need of a life cycle upgrade, functional reassessment and rehabilitation. One hundred percent of the state owned RTH facilities are at the stage of their lifecycle of requiring health and safety rehabilitation.</p> <p>RTH is one of the key essential programs to effectively engage long term stationing of law enforcement officers in rural Alaska. It is important and necessary that these facilities are in healthy, safe and good habitable conditions for the wellbeing of Troopers, Court Service Officers, and their families. In this effort, DPS Facilities has been prioritizing deferred maintenance on department building statewide to rehabilitate properties for the wellbeing of law enforcement officers at work and at home.
