**Public Testimony – Opposing HB 124**

**Craig M. Jones, Fairbanks, Alaska**

Good afternoon, Chair and members of the committee.

For the record, my name is **Craig Jones**, and I am a resident of Fairbanks. I was raised in the upper Kobuk River village of **Ambler**, and I appreciate the opportunity to testify today.

I am here to speak in **opposition to House Bill 124** because I believe it would be detrimental to the Alaska Industrial Development and Export Authority's ability to fulfill its mission and, in doing so, would hinder opportunities for rural and underserved communities across our state.

Growing up in rural Northwest Alaska, I experienced firsthand the challenges that come with isolation—high costs of living, limited infrastructure, and few local economic opportunities. For communities like Ambler, infrastructure investment is not an abstract policy concept; it is the difference between opportunity and stagnation.

AIDEA has played a critical role in changing that reality. One of the most meaningful examples is the **DeLong Mountain Transportation System**, which made possible the development of the Red Dog Mine. That investment did more than support a successful mining operation—it created real opportunity for people like me. I was trained and employed at Red Dog Mine early in my career, gaining skills and experience that set a solid foundation for where I am today. That is what effective development looks like: infrastructure that leads to workforce development and long-term economic mobility for Alaskans.

Beyond individual stories, AIDEA's investments have delivered lasting benefits to Northwest Alaska and the state as a whole—long-term employment, revenue sharing with local communities, durable infrastructure, and measurable financial returns to the State of Alaska. These outcomes demonstrate that AIDEA can be both economically responsible and transformative for rural regions.

House Bill 124, as proposed, would weaken AIDEA's operational effectiveness and independence. In my view, it would make it harder—not easier—for AIDEA to respond to Alaska's unique development challenges and to support the kinds of projects that lift up communities rather than leave them behind.

This concern is especially relevant as we look to the future of the **Ambler Mining District** and other resource opportunities that are critical to Alaska's economy and to national supply chains for critical minerals. Responsible development in these areas depends on having a capable, disciplined development authority with the tools and flexibility to do its job.

I respectfully urge the committee to consider the real-world impacts this legislation could have on rural Alaskans and to oppose HB 124. Preserving AIDEA's strength, independence, and effectiveness is essential if we want to continue creating opportunities across Alaska.
