## FISCAL NOTE ANALYSIS

**BILL NO. HB262**

### Analysis

HB 262 adds a superior court judge to serve in Palmer. Adding judicial capacity will allow more hearings and trials to be scheduled and will move existing cases more quickly to final disposition, while also accommodating future filings in the fastest-growing region of the state.

This increased court capacity will directly increase workload demands on the Palmer District Attorney's Office. Prosecutors will be required to handle more frequent hearings and trials and to litigate cases on accelerated timelines, drawing them out of their offices and away from other essential case preparation and case management work.

The Palmer District Attorney's Office already carries one of the highest average per-prosecutor caseloads in the Criminal Division - an average of approximately 230 cases per prosecutor as of January 13, 2026. The Criminal Division does not have the capacity to absorb this increased demand without sacrificing cases or reallocating resources from other communities. Therefore, the Criminal Division will need an additional Attorney 5 position to respond to the increased court capacity.
