The Alaska State Medical Association (ASMA) represents physicians statewide and is primarily concerned with the health of all Alaskans.

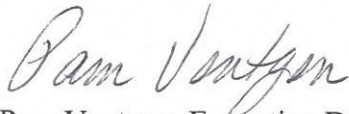
ASMA supports the House Health and Social Services Committee Substitute for House Bill 145.

On behalf of Foundation Health Partners and Denali Pharmacy we ask for your support of HB145. Located at FMH, Denali Pharmacy has a long history of providing patient services to the Fairbanks community. Those services include immunization, medication therapy management, medication reviews, drug information and ensuring patient medications are provided in a timely manner upon discharge.

During the coronavirus pandemic pharmacists were some of the most accessible healthcare professionals available to provide access to care. Throughout the pandemic, our pharmacists provided drug information, emergency prescriptions such as hypertension and diabetes, COVID testing and COVID vaccines in both urban and rural communities.

HB145 provides for pharmacist-patient care services to continue beyond the pandemic. This bill will update pharmacy practice and insurance statutes to:

- Clearly define patient care services pharmacists and pharmacy support staff can independently provide;
- Empower the Board of Pharmacy to regulate pharmacists, student pharmacists, and pharmacy support staff who provide these services; and
- Continue collaborative practice agreements while allowing pharmacists to provide services for general health and wellness, disease prevention, and optimization of medication therapy independently.
- Clarify pharmacists' ability to prescribe vaccines and emergency medications.

The experience through COVID has shown that pharmacists are an integral part of the healthcare team and have been underutilized because of outdated statutes and regulations. Good morning- I am grateful for the opportunity to have spoken to you all this morning. I am providing a written copy of my testimony to aid in incorporation to the written minutes.

Good morning. My name is Susan Wheeler, and I am a resident of Bethel. I am the pharmacy director at Yukon-Kuskokwim Health Corporation. As part of the tribal health system in Alaska, I feel fortunate to have the opportunity to be an integral part of the care team for our patients. The pharmacists here are already engaged in providing several of the services that would be impacted by changes proposed in HB 145. Our pharmacists are fully integrated with the providers, nurses, and other health care professionals who provide care. However, due to the lack of our ability to enroll pharmacists as billing providers, we are unable to receive compensation for the services provided by our pharmacists.

I would like to say thank you for recognizing how important the changes proposed in HB 145 are to our patients, our communities, and to the profession of pharmacy. Pharmacists, in most practice settings, are the most readily available health care professional, yet at the current time in Alaska, they are the only healthcare professionals not listed in the provider antidiscrimination statute. This means that the most readily available health care professionals are compensated minimally, if at all, for providing the same services that would otherwise be covered if provided by other health care professionals. While our profession is dedicated to serving our patients and improving their overall health and well being, the lack of compensation makes it difficult to provide the uncompensated services that we are so well prepared and eager to provide. This makes the services we could provide less readily available to patients, which for some may be a deterrent for some patients and prevent them from obtaining some of the basic medical services that a pharmacist could quickly, easily and competently provide.

So, this morning, I am asking for your support of this important piece of legislation.

Dear Representative Snyder,

I write in unqualified support of passage of HB 145.

This public policy is critically needed.

Public health is the basis of economic function and education of our students. The COVID-19 pandemic has clearly underscored this fact.

When businesses shut down, schools closed and citizens locked down...healthcare providers were on the job, meeting life needs of Alaskans. Pharmacists were vital members of the public health team. Pharmacists and their businesses stayed open.

Physicians and nurses are rightly recognized as front-line workforce. But behind them stood **pharmacists, without whom medications could not have been provided.**

In 2015, with the passage of SB 71 (Chapter 16 SLA 15), pharmacists began administering (and being reimbursed for) vaccinations in their facilities. That made them a critical vaccine access point for Alaskans during the pandemic. If anyone tells you that pharmacists don't know how to administer vaccinations, remind them that they have been safely doing it for several years.

Pharmacists today are required to be educated at the doctoral level. They are the experts on pharmacokinetics (the action of bioactive chemicals on the human body systems). Pharmacists are consulted countless times a day by physicians and Advanced Practice Registered Nurses regarding pharmacologic treatment, drug interactions, availability and cost.

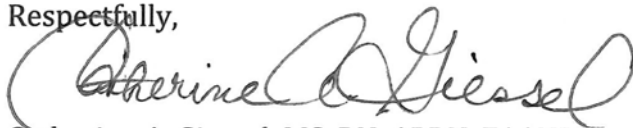
Its time to remove the “middle man” in the management of chronic diseases.

Pharmacists are the experts in the use of prescription and over-the-counter medications in the management of chronic disease. HB 145, as written, will increase access to care and reduce the cost to Alaskans.

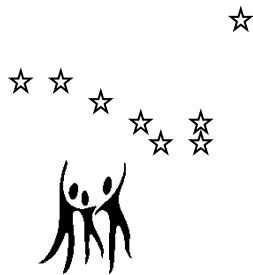
I applaud the **provisions related to pharmacy technicians.** The bill places the Board of Pharmacy as the regulatory oversight for this group of assistive personnel. The bill allows the pharmacy technician to administer vaccinations with the safeguard of Board regulation. This piece of public safety oversight is not present for the medical assistants who work in nearly all the clinics in Alaska; I could tell you stories of errors made by medical assistants giving vaccinations. **HB 145 recognizes the professional expertise and oversight of the pharmacy technician.**

I write in unqualified support of HB 145 and urge legislators to expeditiously pass this public policy. It should be viewed as a piece of critical infrastructure for our state.

Dear Co-Chair Fields, Co-Chair Spohnholz, and Members of the Committee,

The Alaska Public Health Association (ALPHA) supports HB145: "An Act relating to the Board of Pharmacy; relating to health care services provided by pharmacists and pharmacy technicians; and relating to the practice of pharmacy," which expands pharmacists' authority to align with the rest of the extensive list of health care providers.

This bill presents an opportunity to modernize pharmacy practice statutes in several key ways.

- Clearly defines patient care activities pharmacists may provide and empowers the Board of Pharmacy to regulate those services;
- Empowers the Board of Pharmacy to more effectively regulate pharmacy support staff;
- Supports reimbursement for health care services by clearly defining those services; and,
- Updates the current provider anti-discrimination statute to support insurance coverage of these patient care services when provided by a pharmacist (pharmacist are one of the only healthcare professionals not listed in this statute).

Over the past year, Alaska's Department of Health and Social Services temporarily modified pharmacist authority for pharmacists to be able to bill for health care services related to the COVID-19 pandemic. This ensured that pharmacists and pharmacy technicians have been able to fill important gaps related to testing, vaccinations, telehealth visits, and helping patients' manage chronic health conditions. This has had significant implications for increasing access to healthcare services in rural and underserved areas.

We believe that HB145 and the expansion of pharmacist authority to engage at a higher level, consistent with much of what they have already been doing over the past year, will more equitably promote and benefit public health across Alaska communities. We urge the committee to support this bill to help make these changes permanent.

Thank you so much for your consideration of this legislation.

Thank you for sponsoring HB 145, Expand Pharmacists Authority. My family has been operating Island Pharmacy and providing *pharmacy* services in our area for over 47 years now. It is now time to update Alaska statutes to formally include *Pharmacists* in statute for services we are currently providing. Pharmacists at Island Pharmacy have provided over 1,000 Covid-19 doses and were recognized nationally in December for vaccinating assisted living residents the first week that vaccine was available. We are currently finishing up a major remodel so we can better provide *Pharmacist* services such as immunizations in the future.

The coronavirus pandemic has required an all-hands-on-deck situation for all Alaska healthcare professionals. Pharmacists, one of the most accessible healthcare professionals, have rapidly responded to Alaskans' health needs in both urban and underserved rural communities by diligently ensuring residents are well-informed, have access to COVID testing, and are vaccinated.

However, legislation is needed for these beneficial pharmacist-provided patient care services to continue beyond the pandemic. This bill will update pharmacy practice and insurance statutes to:

- Clearly define patient care services pharmacists and pharmacy support staff can provide;
- Empower the Board of Pharmacy to regulate pharmacists, student pharmacists, and pharmacy support staff who provide these services; and
- Update the current provider anti-discrimination statute to support insurance coverage of these patient care services when provided by a pharmacist (pharmacists are one of the only healthcare professionals not listed in this statute). Our pharmacy is currently experiencing payment reimbursement issues related to administration of immunizations. In certain instances this may be due to lack of provider status.

Dear Representative Snyder:

The coronavirus pandemic has required an all-hands-on-deck situation for ALL Alaska healthcare professionals. Pharmacists, one of the most accessible healthcare professionals, are well positioned to rapidly respond to Alaskan's health needs in both urban and underserved rural communities. I have worked directly in my role as an Associate Professor at the UAA/ISU College of Pharmacy and Alaska Pharmacist Association (AKPhA) President Elect and AKPhA Task Force Chair to ensure Alaskan residents are well-informed, have access to COVID testing, and are vaccinated.

Pharmacists and student pharmacists have helped make Alaska the top state for delivered vaccines per capita and one of the safest states during the pandemic. Since Fall 2020, student pharmacists, many of which I have personally supervised have volunteered to administer >750 flu vaccines to vulnerable Assisted Living Home residents, and >1,500 COVID-19 vaccines to Alaskan providers and elders.

We would like to continue providing these critical services when we graduate and thus are writing in support of HB-145: Expand Pharmacist Authority Bill to update the outdated pharmacy practice statutes and insurance statutes. There is a need for legislation to allow this and other essential services to continue beyond the pandemic by updating pharmacy. The goal of HB-145 is to provide clarity to healthcare providers, healthcare systems, and insurers about the medical services pharmacists offer, serving to better align with other healthcare disciplines and the currently enacted insurance code.

Enacted changes will allow pharmacists and student pharmacists to engage at a much higher level both during and after the crisis, increasing access to vital healthcare in all settings in which pharmacists practice (e.g., community, hospital, tribal and federal facilities, and primary care clinics).

I am writing in support of HB 145 Expand Pharmacist Authority.

I am a clinical pharmacist practicing at Anchorage Neighborhood Health Center, where I work directly with primary care providers and patients to ensure medications contribute to the best possible health outcomes. I accomplish this objective by assisting our providers in managing medications for diabetes, hypertension, and dyslipidemia, to name a few. This service is invaluable to our providers, freeing up their busy schedules to provide healthcare services to more patients. I have provided care to the community members of the Anchorage Borough for the past 2 years. It is my hope to continue to provide these invaluable clinical services to our community members for many years to come.

The coronavirus pandemic has required an all-hands-on-deck situation for ALL Alaska healthcare professionals. Pharmacists, one of the most accessible healthcare professionals, are well positioned to rapidly respond to Alaskan's health needs in both urban and underserved rural communities. Pharmacists and student pharmacists participating in the Alaska COVID-19 response have worked diligently to ensure Alaskan residents are well-informed, have access to COVID testing, and are vaccinated.

Over 100,000 Alaskans have received the first dose of COVID-19 vaccine, making Alaska the top state for delivered vaccines per capita and one of the safest states during the pandemic; however, few know the role pharmacists have had in making this a reality. Over the past year pharmacists were mobilized across the state administering thousands of COVID point-of-care tests, flu and COVID vaccines across the state. Pharmacists in primary care clinics have provided hundreds of telehealth visits, helping patients manage their chronic health conditions (e.g., hypertension, diabetes, etc.) when many healthcare facilities were unable to meet the needs.

During the Pandemic, pharmacists increased access to healthcare by providing COVID testing and vaccines; however, there is a need for legislation to allow this and other essential services (i.e., disease state management for chronic diseases) to continue beyond the pandemic by updating pharmacy practice statutes and insurance statutes. To ensure these beneficial pharmacist-provided patient care services continue, a few items need to be "cleaned-up" in current statutes. The purpose of this bill is to modernize the pharmacy practice statutes to:

- Clearly define patient care services pharmacists and pharmacy support staff provide.
- Empower the Board of Pharmacy to regulate patient care services pharmacists, student pharmacists, and pharmacy support staff provide.

- Update the current provider anti-discrimination statute to support insurance coverage of pharmacist-provided patient care services. Note that pharmacists are the ONLY health care profession not covered in the state provider anti-discrimination statute.

The COVID experience has also shown that pharmacists have been underutilized simply as a result of outdated statutes and regulations. Enacted changes will allow pharmacists to engage at a much higher level during and after the crisis. In addition, without these changes, I will be unable to sustain my clinical pharmacist position due to the absence of reimbursement for services rendered. I have and will continue to increase access to needed health services for our community, but only with the help of these legislative changes. I look forward to continue supporting the healthcare team at Anchorage Neighborhood Health Center for many years to come.

Our primary care, integrated pharmacists offer in depth consults and medication training. Our tele-pharmacists navigate the challenges of remote healthcare and provide training and pharmaceutical services via PickPoint and mailing prescriptions. Even our central staffing pharmacists partner with outside programs like our homeless shelters and detox center to provide training, education and pharmacy services. During the pandemic, these services continued and additional priorities were added including supporting our mass vaccination clinic where we vaccinated up to 950 people per day. Pharmacists manned the vaccine station and consulted on vaccine questions. We also had seven pharmacy technicians step up and get vaccination certified so they could assist in the effort.

Pharmacists are valued contributors in healthcare and are providing quality services but have been unable to bill for these services. HB 145 will modernize the profession in Alaska.

I have worked directly in my role as an Associate Professor at the UAA/ISU College of Pharmacy and Alaska Pharmacist Association (AKPhA) President Elect and AKPhA Task Force Chair to ensure Alaskan residents are well-informed, have access to COVID testing, and are vaccinated.

Pharmacists and student pharmacists have helped make Alaska the top state for delivered vaccines per capita and one of the safest states during the pandemic. Since Fall 2020, student pharmacists, many of which I have personally supervised have volunteered to administer >750 flu vaccines to vulnerable Assisted Living Home residents, and >1,500 COVID-19 vaccines to Alaskan providers and elders.

On behalf of Bristol Bay Area Health Corporation (BBAHC) a consortium of 28 Alaskan Native Tribes in Southwest Alaska, I write in support of House Bill 145, an Act to Expand Pharmacist Authority.

The corporation oversees 21 village-based clinics and operates the Kanakanak Hospital, a Critical Access Hospital accredited by The Joint Commission.

In both urban and rural communities, especially underserved areas, pharmacists provide critical services to patients in need of timely and efficient care. From vaccine administration and clinical advice, to prescription drug monitoring and ongoing management of many chronic health conditions, pharmacists are an essential component to ensuring Alaskans have access to needed care across the state.

While pharmacists have always played an important role in Alaska's health care system, the COVID pandemic highlighted their necessity in meeting individual patient needs and strengthening community-based health efforts. From telehealth visits to in-person vaccine administration, pharmacists allowed Alaskans to remain safe and healthy during a time of immense staffing and capacity strain on Alaska's health care system.

While hospital and provider groups have long recognized the critical role, pharmacists play in health care facilities and communities across the state, legislation is needed to align existing practices and authorities with statute.
