## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2026 LEGISLATIVE SESSION

BILL NO. HB 250

### Analysis

This legislation establishes a new misdemeanor offense prohibiting a peace officer from wearing a mask or disguise while interacting with the public in an official capacity, with specified exceptions for undercover assignments, medical necessity, protective equipment, and smoke exposure.

The Department of Public Safety, through the Alaska State Troopers, is already responsible for enforcing state criminal statutes applicable to peace officers. The bill does not create a new enforcement program, expand investigative authority, require additional training, or impose new administrative or regulatory duties on the department. Any enforcement or compliance considerations would be handled within existing supervisory, disciplinary, and investigative frameworks.

The department does not anticipate an increase in workload, staffing, or operating costs as a result of this legislation. Any potential cases arising under the new statute can be absorbed within existing resources.

There is no fiscal impact anticipated to the Department of Public Safety.
