I have been an attorney and resident of the State of Alaska since 1969.

Since I am sure that the public hearing on this bill will be very crowded, I wanted to submit my brief testimony on this bill by email. I thank you for the appropriate distribution of this email.

I support parental notification/consent for the performance of an abortion on one of their children. Parental consent is required for any other medical procedure performed on a minor child. An abortion is a serious medical procedure, with particular emotional overtones. There is no reason that parental notification and consent should not be required as it is for ordinary medical procedures.

In the rare case where the matter cannot be dealt with between the parents and the child, HB 35 provides for judicial intervention. Whether or not you believe that the judiciary should be allowed to interfere in the intra-family relationships, this judicial oversight provision will help when HB 35 is enacted and then if it is challenged in Court.

In summary, I support HB 35. Thank you.

Alaskan parents and families are relying on you this session to vote "NO" on House Bill 35 (Parental Consent and Notification).

As a female Alaskan resident and voter, I believe it is your duty on a personal level, and a professional level to hear my concerns and act upon them. For this reason, I have taken time out of my intensely homework laden collegiate existence to compose this letter to you. Please do not simply ignore it, since you know as well as I do that your duty is to your constituents, which I am one of. Thus I am here to share my concerns and voice my disapproval of HB 35.

In Alaska, for the most part, teens and parents have decent communication. However, there are also a great deal of broken families held together only by the necessity for financial codependence. Unfortunately it is in these families that the parents are often so focused on themselves that the children are left by the wayside as the "adults" attempt to battle out their differences and become increasingly embittered. It is in these types of situations that kids are often NOT given the proper sexual education, NOT offered birth control, and NOT given the understanding that would allow a woman to make the right decision-- a decision NOT made to appease parents or save face for the family.

You do see the problem...

In a home where communication is not possible, desperate Alaskan teens will take desperate measures.
