This bill creates procedures for obtaining post-conviction DNA testing, for preserving physical evidence, for destroying physical evidence, and creates a task force on standards for preservation of evidence.

It is expected that the Agency will receive new post-conviction appointments. The Innocence Project has recieved approximately 130 requests for assistance from convicted defendants asserting claims of innocence over the past 4 years. Additionally, the bill requires all petitioners whose convictions were entered before a certain date to file a petition by July 1, 2013. This is expected to increase the number of applications within the first three years of the bill. (continued on page 2)
