A BILL

FOR AN ACT ENTITLED

"An Act relating to the Alaska scholars program administered by the Board of Regents of the University of Alaska and to scholarship information; repealing provisions related to University of Alaska scholarships; relating to the AlaskAdvantage Education Grant Program; and relating to professional student exchange program availability and conditions for loan repayment under that program and the medical education program."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* **Section 1.** AS 14.43 is amended by adding new sections to read:

Sec. 14.43.011. Creation of the Alaska scholars program. The Alaska scholars program is created as a scholarship program to be administered by the Board of Regents of the University of Alaska.

Sec. 14.43.021. Scholarship eligibility. (a) To be eligible for a scholarship from the Alaska scholars program, a student shall

- (1) be a United States citizen or an alien lawfully admitted for permanent residence in the United States; and
- be academically ranked in the top 15 percent of the student's secondary class at the end of the student's junior year as determined by each qualified high school in the state.
- (b) To receive a scholarship disbursement from the Alaska scholars program, the student shall
- (1) have a high school diploma from a qualified high school in the state;
- (2) by the fall semester that begins within 16 months following the student's high school graduation, be accepted to a certificate or degree program of the University of Alaska; and
 - (3) be enrolled as a full-time student at the University of Alaska.
- (c) To maintain eligibility for a scholarship disbursement under AS 14.43.026, the student shall
- (1) successfully complete at least 12 credit hours of courses of the University of Alaska each semester;
- (2) be in good standing in accordance with University of Alaska institutional and program standards; and
- (3) be making progress toward completion of a certificate or degree program.
- Sec. 14.43.026. Scholarship award. (a) The president of the University of Alaska shall award to an eligible student under the Alaska scholars program a scholarship of
- (1) 100 percent of the cost of 15 credit hours of regular tuition at the University of Alaska for a student who is in the top five percent of the student's secondary class;
- (2) 75 percent of the cost of 15 credit hours of regular tuition at the University of Alaska for a student who is below the top five percent and in the top 10 percent of the student's secondary class;
 - (3) 50 percent of the cost of 15 credit hours of regular tuition at the

University of Alaska for a student who is below the top 10 percent and in the top 15 percent of the student's secondary class.

- (b) Disbursements under this section may not be made for more than eight semesters or for enrollment commencing more than five years after initial enrollment at the University of Alaska.
- (c) The award may be used only for tuition, fees, room, board, books, supplies, necessary transportation, and other costs incurred for attendance at the University of Alaska.
- (d) The board of regents may adjust the amount of the scholarship award and disbursement to reflect changes in the cost of education or the amount of funding provided by the state.
- **Sec. 14.43.031. Financing; administration.** (a) The Alaska scholars program account is established, to be administered by the board of regents. The Alaska scholars program is financed from the account. The account consists of money appropriated to the account by the legislature, which may include appropriations from the endowment trust fund established under AS 14.40.400, from income and earnings of the account, and from any other source. Appropriations to the account do not lapse.
- (b) The board of regents shall provide not less than \$3,800,000 annually to contribute to the awards provided under AS 14.43.026(a).
- (c) The board of regents shall make information about the scholarship program available in each school district in the state and at each campus of the University of Alaska.
- (d) The board of regents may adopt rules, orders, and plans to implement AS 14.43.011 14.43.049. The rules may include provisions for discretionary eligibility consideration and leaves of absence that are consistent with the purposes of the Alaska scholars program.

Sec. 14.43.049. Definitions. In AS 14.43.011 - 14.43.049,

- (1) "accredited" means a school that has been accredited by the Northwest Association of Accredited Schools;
- (2) "board of regents" means the Board of Regents of the University of Alaska;

- (4) "qualified high school" means a public or private secondary school located in the state that is authorized by the department to issue a diploma and that is accredited by the Northwest Association of Schools and Colleges or registered with the department;
 - (5) "scholarship program" means the Alaska scholars program.
- * Sec. 2. AS 14.43.410 is amended by adding a new subsection to read:
 - (c) The commission shall annually distribute not less than \$10,000,000 or, if available funding from appropriations and other sources is less than that amount, the full amount available in grant awards on behalf of eligible students under AS 14.43.415. Payments shall be made directly to the postsecondary or lending institution if feasible. If available funds are insufficient to fully fund grants to eligible students, the commission shall distribute funds to eligible applicants on a pro rata basis.
- * **Sec. 3.** AS 14.43.415(a) is amended to read:
 - (a) For an applicant to be eligible for a grant under AS 14.43.400 14.43.420, the applicant must be
 - (1) a resident of this state;
 - (2) enrolled or about to be enrolled
 - (A) at an institution [APPROVED TO PARTICIPATE IN FEDERAL FINANCIAL AID PROGRAMS UNDER 20 U.S.C. 1070 1099-2, AS AMENDED,] located in this state **that**
 - (i) is approved to participate in federal financial aid programs under 20 U.S.C. 1070 1099c-2, as amended; or
 - (ii) has been included on a list of certified career and technical school programs approved and published by the Department of Labor and Workforce Development; and
 - (B) on at least a half-time basis; and
 - (3) able to demonstrate financial need in accordance with standards for determining financial need established by the commission under 20 U.S.C. 1070c-2, as

- (b) The commission shall give an applicant eligible under (a) of this section priority for a grant award if that applicant is, or is about to be, enrolled in a postsecondary education program that prepares the applicant for employment in an occupation or profession for which there is a severe shortage of trained individuals in the state. In this subsection,
- (1) "occupation or profession" means a job for which specific postsecondary certification is a prerequisite for entry-level placement;
- (2) "severe shortage" means a current or recurring job vacancy rate of 15 percent or greater, as determined by the Department of Labor and Workforce Development or by another workforce data source determined reliable by the commission.
- * **Sec. 5.** AS 14.43.420(a) is amended to read:
 - (a) A grant made under AS 14.43.400 14.43.420 may not be in an amount less than **\$1,000** [\$500] nor more than **\$5,000** [\$2,000] for each school year.

- (2) "qualified high school" has the meaning given in AS 14.43.049 [MEANS A PUBLIC HIGH SCHOOL, A HIGH SCHOOL ACCREDITED BY THE NORTHWEST ASSOCIATION OF SCHOOLS AND COLLEGES, OR A HIGH SCHOOL REGISTERED WITH THE DEPARTMENT].
