## Column Definitions

**Senate 1 (Senate Sec. 1 Supplemental)** - Includes capital projects in the Governor's FY10 supplemental request and other FY10 effective language sections as amended by the Senate.

**Senate 4 (Senate Sec. 4 Def. Maintenance)** - Includes the Governor's Deferred Maintenance projects request as amended by the Senate.

**Senate 7 (Senate Sec.7 FY11 Capital)** - Includes the Governor's primary Capital Bill request as amended by the Senate. Also includes language section items effective in FY11.

**Senate10 (Senate Section 10 Grants)** - Section consists of all grants to Named Recipients, Municipalities and Unincorporated Communities. This section is effective in FY10.

**Senate13 (Senate Sec. 13 Cruise Projects)** - Section consists of the Governor's requested cruise ship related projects as amended by the Senate.

**Senate16 (Senate Sec. 16 GO Bonds)** - Section consists of appropriations from General Obligation Bonds to be placed on the ballot for voter approval.

**GovTotal (Governor's Total Amended)** - Governor's Total Amended Capital Request - Includes Supplemental Capital, Deferred Maintenance Capital, and Main Capital bills. Also includes requested amendments post the statutory deadline.
