BILL NO. HB212

### Analysis

This bill would require provisional drivers to adhere a sticker to the vehicle that they are operating that designates them as a provisional driver's license holder. It would also make it an infraction with a fine of not more than \$300 for failure to display the sticker. This bill will have a minor fiscal impact on the Division of Motor Vehicles (DMV) for producing the provisional stickers. DMV will absorb the costs in its operating budget and therefore submits a zero fiscal note.
