### **MEMORANDUM**

**SUBJECT:** Title change may be needed; amendments to HCS CSSB 89(STA)

(Work Order Nos. 27-LS0452\O.1 & O.2)

Enclosed are the two draft amendments, O.1 and O.2, that you requested for the bill referenced above.

The Constitution of Alaska, article II, section 13 requires that the subject of each bill shall be expressed in the title. There may be an issue as to whether proposed amendment O.1 will require a title change to the bill that it is amending. If a title change is required to this house bill in the Senate, a joint resolution would be required to suspend Uniform Rules 24(c), 35, 41(b) and 42(e), which prohibit changes to a bill's title in the second house. Although amendment O.1 explicitly concerns the ostensible authority of the Select Committee on Legislative Ethics to establish disclosure deadlines by adopting regulations, it would probably fit within the title under "amending disclosure deadlines under the Legislative Ethics Act," on page 1, line 12, because it relates indirectly to disclosure deadlines in the Legislative Ethics Act. On the other hand, it could be argued that the amendment does not fit within the title because it does not actually amend an existing deadline. If you want to exercise the most caution, the amendment could be revised to include a title change. If the title is changed, the committee may ask for a concurrent resolution at the time a committee substitute is prepared.
