### Analysis

This bill requires the Department of Health and Social Services to investigate varied effects of airport security screening in general. The study would need to investigate the potential for psychological trauma to travelers who have been diagnosed with cancer, had surgical resection or implant of a body part, been victim of a physical or sexual assault, or who sustained an injury related to work or war. Physical effects from airport security screening are also to be assessed.

If passed, this bill would necessitate that DHSS contract one or more outside agencies to perform the studies and oblige DHSS to assign one or more epidemiologists to oversee the work of the contractor(s). It would likely require at least three separate studies, including a behavioral health study, a radiological study, and a toxicological study. Each of these studies would require development of a study protocol, institutional review board review, and at least two years to successfully implement and write-up.

The increased workload to DHSS for oversight of this project would be substantial. Except for an extrapolation from existing data regarding cancer risk, the other studies could be a challenge and expensive. This fiscal note includes two Public Health Specialist II positions at a cost of \$136.8 each (\$273.6 total) for a two-year duration: one medical epidemiologist for the radiological and toxicological studies and one behavioral epidemiologist for the behavioral health study. There are additional costs for travel to the four sites and administrative overhead for office space, supplies, phones, and computers.

Each of the three studies is estimated to cost at least \$100.0 (\$300.0 total), although the actual cost could be two- to three-times as much, depending on the final study design.
