CSSSSB 82 has zero fiscal impact on the Department of Health and Social Services. This bill addresses permanent planning for children in custody under "Another Planned, Permanent Living Arrangement "(APPLA); modifies licensing procedures; outlines court requirements for release or termination of custody by the courts; outlines "compelling reason" standards for youth with APPLA permanency goals; provides a provision to support placement of siblings into the same foster home; and adds a new provision requiring the streamlining of the foster parent application process and the approval of building code variance requests under specified circumstances. No additional costs are
anticipated.
