III. <u>Transition to Communities/Prison Employment Program</u>

The Department of Corrections is currently implementing the Alaska Re-Entry Manual/Program in all institutions statewide as well as in our contracted facility in Hudson, Colorado. The manual is presented and provided to all inmates prior to release and assists them in obtaining identification, provides them with a resume writing workshop, interview skills and community referral tools such as job centers that have a history of employing convicted felons.

The Department of Corrections previously had a Prisoner Employment Program (PEP). This was a Receipt Supported Services program, i.e. the program was required to be self-sufficient and balance their sales with their receipts, operating as business. PEP was discontinued in FY10 due to insolvency and in favor of vocational education and inmate operations employment. PEP starting falling into arrears in FY08 when energy costs and associated surcharges on commodities skyrocketed. PEP was never able to recover from FY08 and continued to increase their deficit in the subsequent fiscal years. The Department could not in good faith allow this trend to continue and made the difficult decision of discontinuing PEP as of 6/30/10.

Although PEP programs were completely discontinued, the Laundry Services program located at Lemon Creek Correctional Center continues to serve the Alaska Marine Highway System (AMHS) not as a PEP, but rather a vocational education program, employing up to 18 inmates at one time. The program serves only the AMHS at this time and is funded through Interagency Receipt Authority—AMHS is the requesting agency and DOC is the servicing agency.
