Analysis

Currently, possession of a schedule IIIA is a Class A misdemeanor if the amount possessed is less than 3 grams (AS 11.71.050) or a Class C Felony if the amount possessed is over 3 grams (AS 11.71.040). Manufacturing or delivering a schedule IIIA controlled substance is a Class B felony (AS 11.71.030). The sentences for these crimes range anywhere from 0 - 10 years. The current average daily cost to house an inmate is \$136.44. Therefore, housing an offender could cost the department anywhere from \$0.0 (no time served) to \$498.1 (for a 10-year sentence).
