STATE OF ALASKA 2011 LEGISLATIVE SESSION

BILL NO. CSHB 21(STA)

This bill will increase the size of the Statewide Suicide Prevention Council by one member, from a total membership of 16 to 17. The additional member being requested is someone specifically representing the military. In addition, the definition of the youth member has been revised to include an age demarcation, and eliminates the need to be currently enrolled in a secondary school in Alaska.						
The proposed changes will result in increased travel costs for the Council. Four meetings are held each year at varying locations. Based on historical costs, it is estimated that the additional travel costs for an additional council member will be \$3,950.00 per year.
