## Alaska Pioneer Homes

#### Mission

To provide the highest quality of life in a safe home environment for older Alaskans and Veterans.

#### **Purpose**

Provide subsidized residential elder care.

#### **Current law**

The Department . . . shall adopt regulations establishing a monthly rate for the compensation a resident is to be charged. . . . The rate charged need not fully compensate the state for the cost of care and support.

AS 47.55.030(b).

"Provide acceptance and use of the United States Marine Barracks buildings at Sitka, Alaska, as a home for indigent prospectors and others who have spent their years in Alaska and become dependent. . . ."

Original enabling legislation: H.B. 94, First Territorial Legislature.

Signed into Law April 30, 1913


### **Program**

The Division maintains and operates five Pioneer Homes and the Alaska Veterans and Pioneer Home:

- ➤ The services provided over time have ranged from room and board to skilled nursing care.
- ➤ The focus today is residential assisted living under The Eden Alternative<sup>TM</sup> care concept.
- ➤ All six facilities are licensed as assisted living homes.
- Any Alaskan age 65 or over that has been an Alaska resident for at least one year immediately preceding application for admission and is in need of aid is eligible for admission.



#### **Payor Mix Definitions**


- > Private Pay
  - ✓ Either person's own assets/savings or long term care insurance;
- > Medicaid Waiver
  - ✓ Alaska's waiver created December 1993
    - Applicant must meet nursing home level of care to qualify
    - Primarily Level II & III residents for Pioneer Homes
  - ✓ 87: Current Pioneer Homes residents on the Medicaid waiver
  - ✓ 2,800: Medicaid waiver recipients statewide
- ➤ Payment Assistance
  - ✓ The original Pioneer Homes benefit
  - ✓ Sliding scale benefit based on ability to pay
  - ✓ Amount of payment assistance becomes a debt to the state
  - ✓ No other state provides assisted living in quite the same way
    - 29 states: Medicaid Waiver
    - 10 states: Combination of Medicaid waiver and Medicaid state plan; or
    - 6 states: Medicaid state plan only

#### **Pioneer Homes Admission and Wait List**

Individuals apply for admission to an Alaska Pioneer Home or the Alaska Veterans and Pioneer Home by completing and submitting an application.

- ➤ The date and time of the application's submission determine the order of admission into the Pioneer Home system.
- An applicant chooses to move onto the "active" wait list when they are willing and ready to move into a Pioneer Home within 30 days of an offer.
- Invitations to enter a Pioneer Home are only offered to those on the active wait list.
- ➤ When a bed becomes vacant in a particular level of service, the applicant offered admission is the person whose name is listed on the active wait list as having the earliest date of application.
- > The applicant is admitted if the level of service the applicant requires matches the level of service of the available bed.
