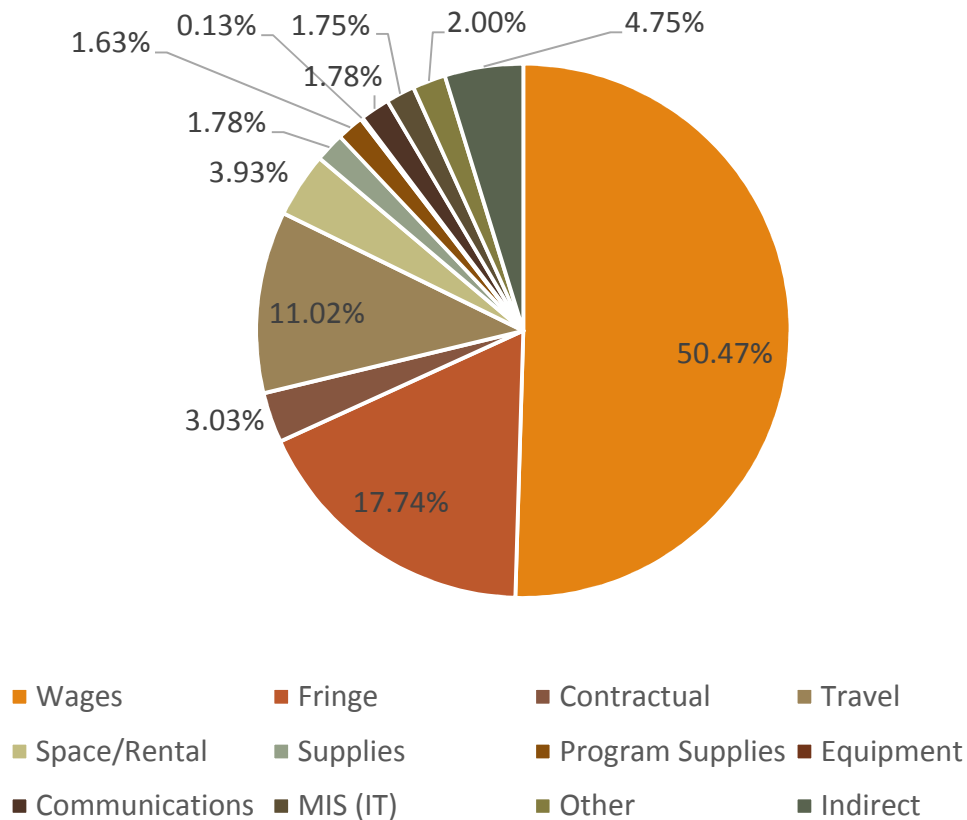

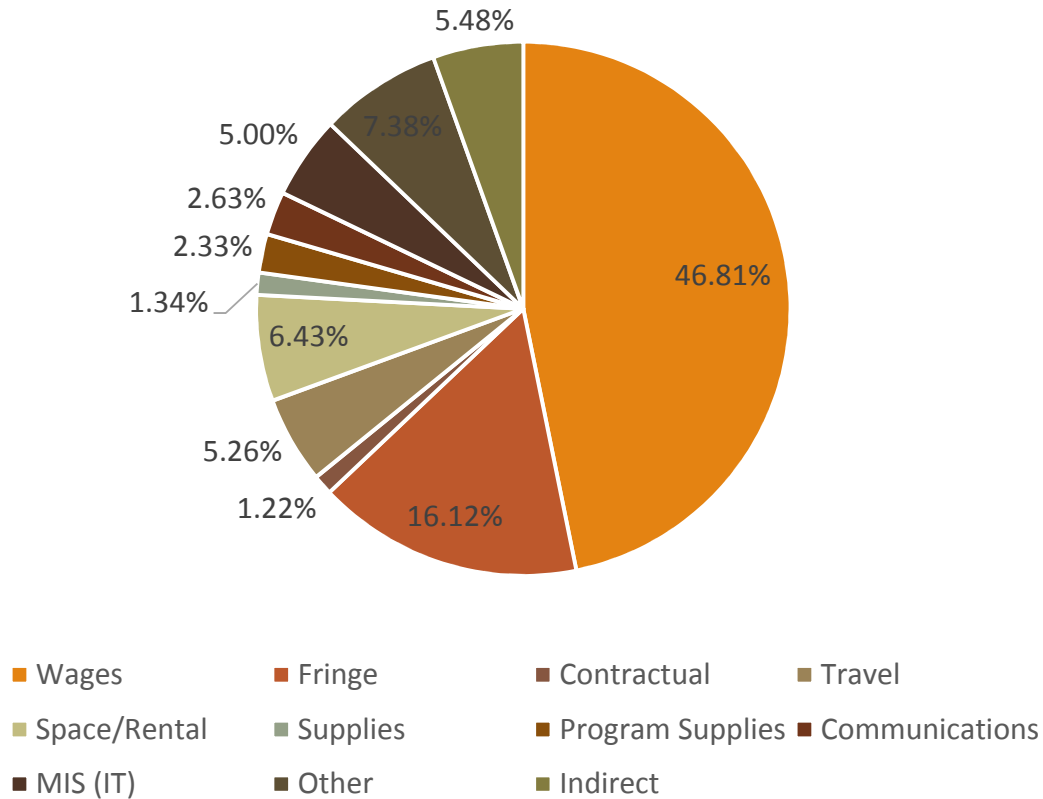

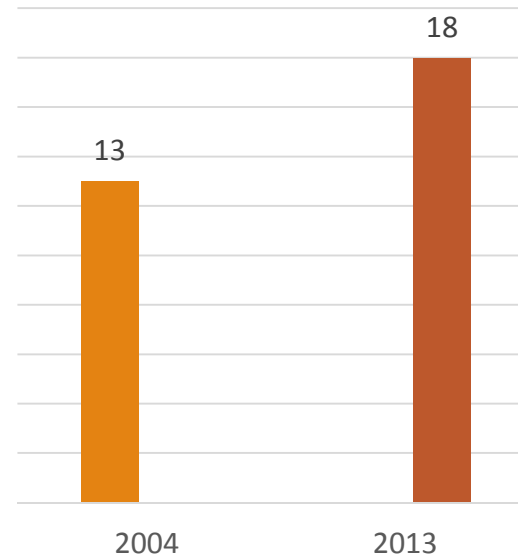


# Parents as Teachers: Families and Communities Served

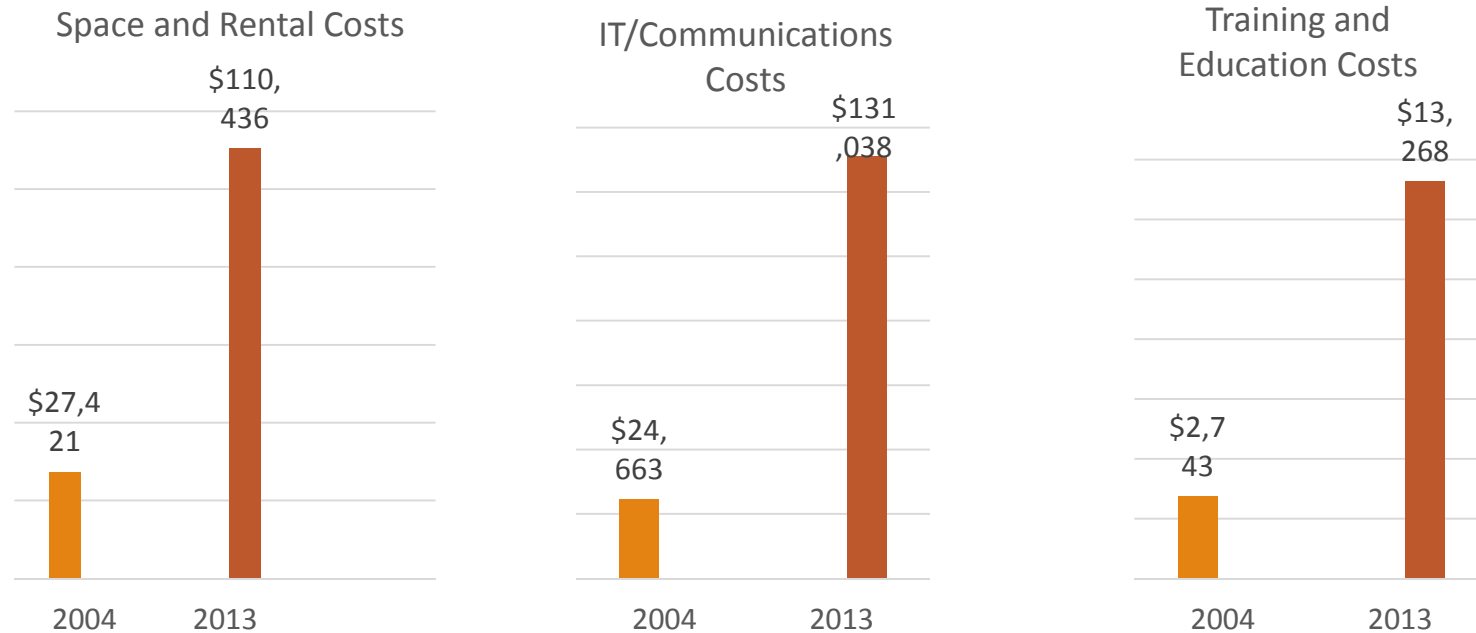
Cost per Family

# Parents as Teachers Outcomes

---

- 221 parents completed at least 75% of scheduled personal visits
- 211 parents reported an increase in activities promoting literacy and language development
- 210 parents reported improved parenting skills related to positive discipline
- 377 children demonstrated age appropriate developmental skills

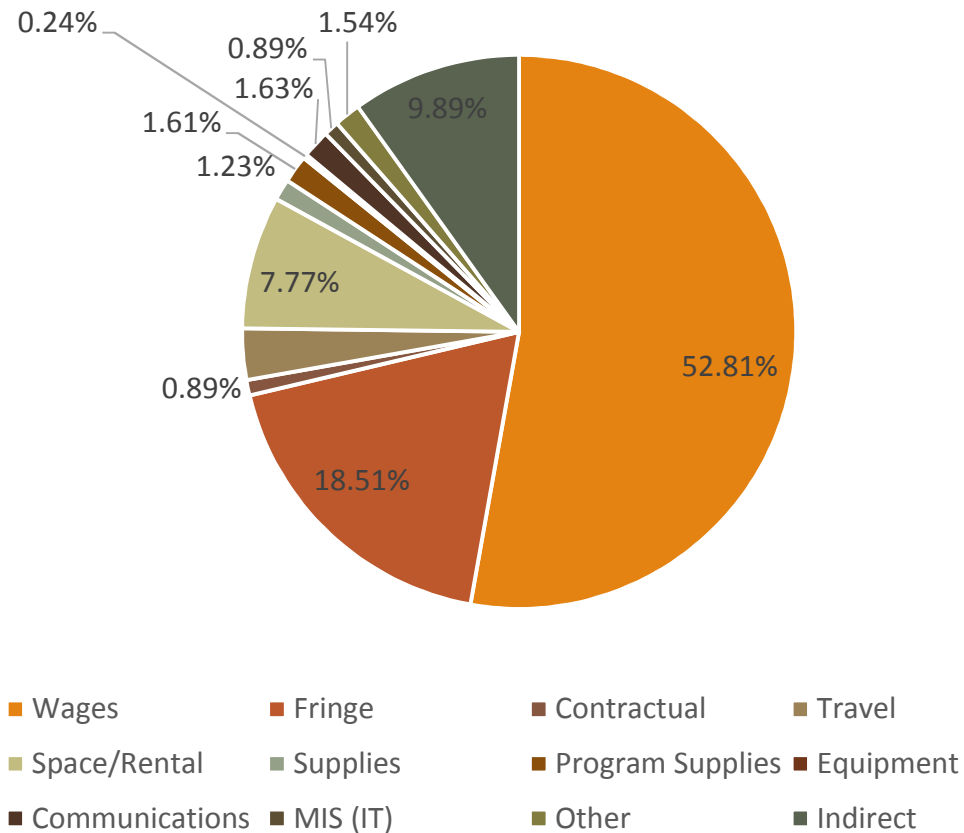

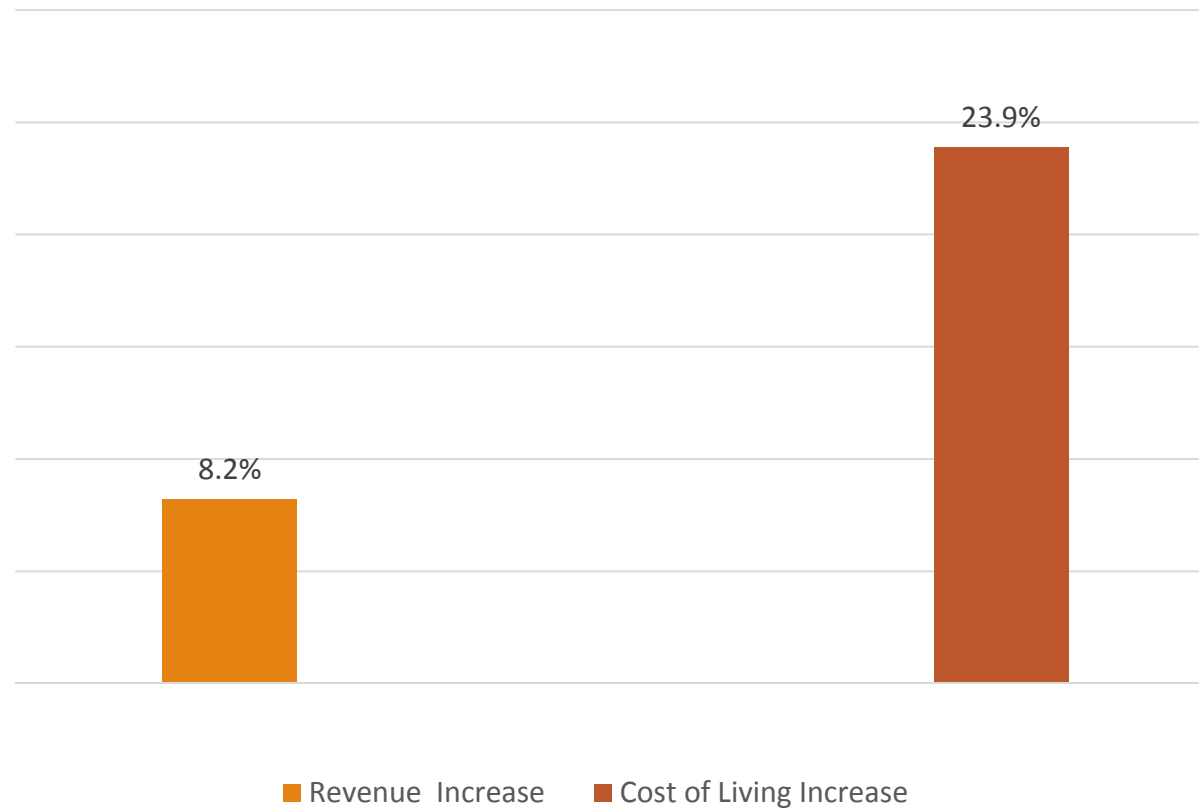

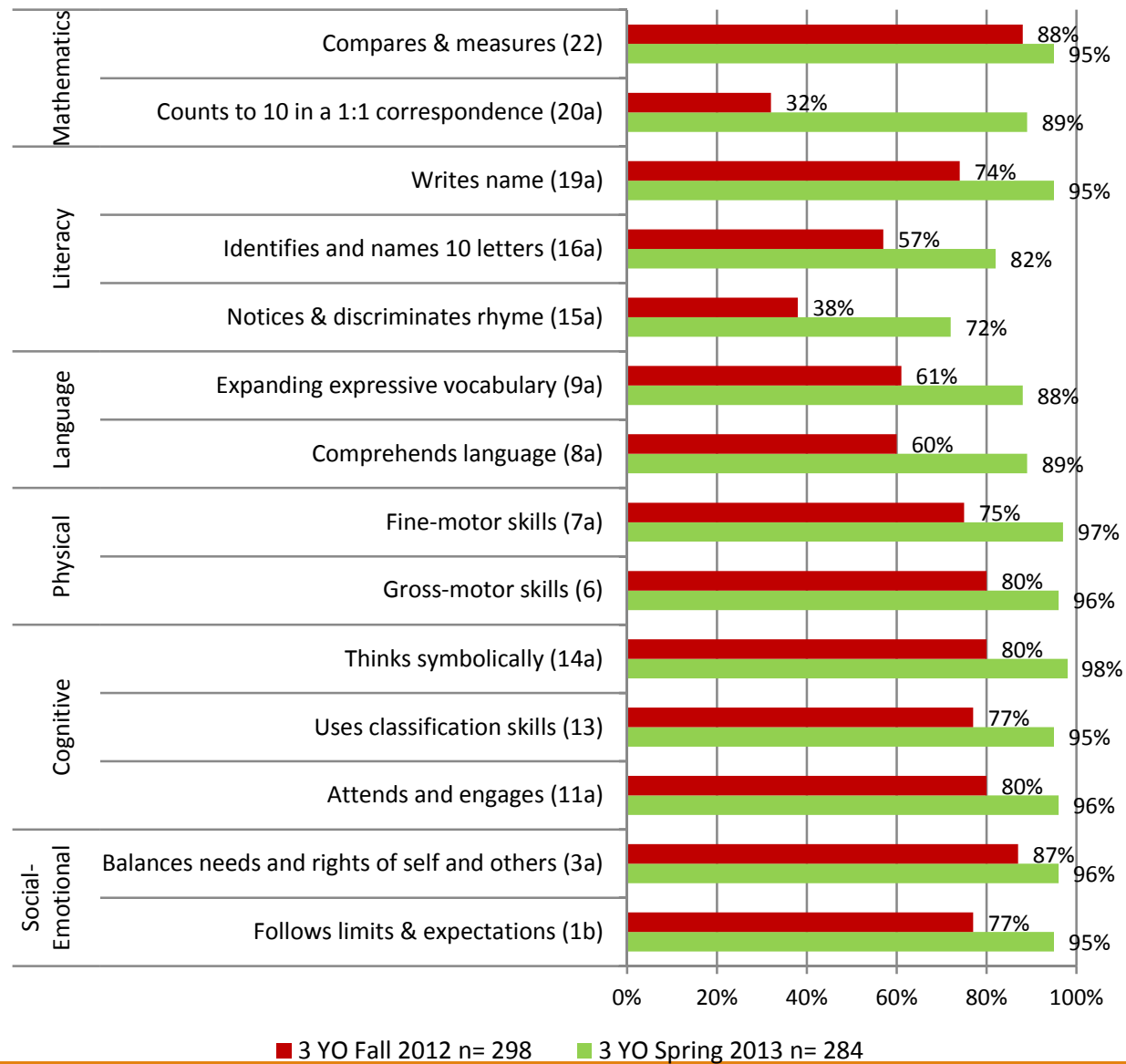
