Janie Leask, alternate public member, was appointed by Chief Justice Dana Fabe on September 19, 2013 to fill the regular public member vacancy due to Toni Mallot's resignation. (See attached appointment letter.)

On January 13, 2014, Chief Justice Dana Fabe appointed Christena Williams to fill the alternate public member vacancy. (See attached appointment letter.)

Both Ms. Leask and Ms. Williams name has been referred to Senate President Charlie Huggins and Speaker Mike Chenault. Their names will be referred to the Senate and House Judiciary Committees for confirmation hearings. Each appointment requires ratification by two-thirds of the full membership of each body.

Chief Justice Fabe:

RE: Public Member Vacancy on the Ethics Committee

Toni Mallott submitted her resignation letter today to the committee. (Attached.) Her insight from both a rural and Native Alaskan perspective into legislative ethics issues will be missed.

Under AS 24.60.130(e) you may appoint an individual during the interim to fill the vacancy. Most often this is the course of action taken by the chief justice. The appointment could also be made at the beginning of the 2014 legislative session.

This is the first year the committee has had an alternate public member position. After consulting with our internal legal counsel and reviewing the statutory language regarding a vacancy, you have several options.

According to the statute, Jamie Leask, alternate public member, remains as an alternate member and does not automatically move into the position of regular public member. However, you have the option of appointing her to fill the regular member vacancy at any time during the interim. If that were to occur, appointing an alternate public member would be required. The timing of appointing an alternate public member could occur at any time. Committee Chair H. Conner Thomas had indicated that as long we have a full complement of five public members for the remainder of the year, an additional appointment during the interim, whether as a regular member or an alternate public member, would not be crucial to the operation of the committee.

Of course, the other option is to appoint a new public member to fill the vacancy and Ms. Leask would remain as the alternate member on the committee.

I talked to Ms. Leask on Thursday, September 11, and she indicated she would be interested in moving into the regular member vacancy position. She can be reached at 250-1944. She recently moved from Anchorage to Homer.



RE: Alternate Public Member Vacancy

Under AS 24.60.130(b)(3) and (e) the five public members of the Select Committee on Legislative Ethics and one alternate public member are appointed by the Chief Justice and ratified by two thirds of the full membership of each house of the legislature. For your information, attached is a listing of current Committee members.

No public members' terms will expire in 2014. However, there is a vacancy for the alternate public member position. Due to the resignation of Antoinette Mallott, you appointed Janie Leask, the alternate public member, on September 19, 2013, to fill the regular public member position. The appointment created a vacancy for an alternate public member. (Note: Your letter of September 19, 2013, will serve as notice to the Senate and House of Ms. Leask's appointment as a regular public member. The House and Senate will hold confirmation hearings in 2014 since her status changed from alternate to regular public member.)

The alternate public member's qualification and selection process is similar to that of a regular public member. AS 24.60.130(c) and (m) set out the requirements and prohibitions for regular and alternate public members (see attached). Interested individuals are instructed to send a resume and letter of interest to your attention.¹

¹ The committee recognized there was no formal process for announcing public member vacancies on the ethics committee. The ethics website now contains a section titled "Public Member Appointments and Vacancies (http://ethics.legis.state.ak.us) detailing the process for public member appointments. Interested individuals are instructed to send a resume and letter of interest to your attention. A public notice is sent to all twenty-two Legislative

We are suggesting that interested individuals submit a letter and resume to your office by Friday, January 31, 2014. The timeframe of one month is a reasonable amount of time. Let me know if you agree or if you feel the timeframe should be longer. A letter appointing an alternate public member in February would still allow enough time for the House and Senate confirmation process to be completed during the 2014 legislative session.

(NOTE: Chief Justice Dana Fabe called on January 8 and asked that the application process be open ended instead of a listed deadline. The notice was updated to reflect the change.)


