A BILL

FOR AN ACT ENTITLED

1 "An Act relating to unmanned aircraft systems; and relating to images captured by an

2 unmanned aircraft system."

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

4 * Section 1. AS 14.40 is amended by adding a new section to read:

5 Sec. 14.40.082. Unmanned aircraft system training. The University of 6 Alaska may establish a training program in the operation of unmanned aircraft 7 systems.

8 * Sec. 2. AS 18.65 is amended by adding new sections to read:

Article 13. Law Enforcement Use of Unmanned Aircraft Systems.

10Sec. 18.65.900. Use of unmanned aircraft systems. Except as provided in11AS 18.65.900 - 18.65.909, a law enforcement agency may not use an unmanned12aircraft system.

13 Sec. 18.65.901. Operational requirements for unmanned aircraft systems. 14 (a) A law enforcement agency shall adopt procedures for the use of unmanned aircraft

systems. The procedures adopted under this section must require, at a minimum, that
 the law enforcement agency
 (1) obtain any authorization, permit, or certificate required by the

3 (1) obtain any authorization, permit, or certificate required by the
4 Federal Aviation Administration to operate the unmanned aircraft system;

5 (2) allow the unmanned aircraft system to be operated only by 6 unmanned aircraft system pilots and crew members who have been trained and 7 certified in the operation of the unmanned aircraft system and only under the 8 supervision of officials trained in the policies and procedures governing the use of the 9 unmanned aircraft system;

10 (3) provide that the flight of an unmanned aircraft system be approved
11 by the chief administrative officer of the law enforcement agency or the officer's
12 designee;

13 (4) ensure that the flight of an unmanned aircraft system be for a
public purpose;

15 (5) maintain a record of each flight, including the time, date, and
purpose of the flight, and the identity of the authorizing official;

17 (6) establish an auditable flight record system, including the18 documentation of a change in a flight time record;

(7) establish a method for notifying the public of the operation of an
unmanned aircraft system, unless notifying the public would endanger the safety of a
person;

(8) provide for community involvement in the development of the
policies required in this section, including the consideration of public comment.

(b) In adopting procedures under (a) of this section, a law enforcement agency
shall adopt the International Association of Chiefs of Police, Recommended
Guidelines for the Use of Unmanned Aircraft.

27 (c) In this section, "chief administrative officer" has the meaning given in28 AS 18.65.290.

 investigation. A law enforcement agency may use an unmanned aircraft system to
 gather evidence in a criminal investigation

5	Sec. 18.65.903. Retention of images. (a) A law enforcement agency may not
6	retain images captured by an unmanned aircraft system unless retention of the image is
7	required
8	(1) as part of an investigation or prosecution;
9	(2) for training purposes; or
10	(3) by federal or state law or by municipal ordinance.
11	(b) Images retained under this section are subject to AS 40.25.100 - 40.25.295
12	and the exceptions to disclosure under AS 40.25.100 - 40.25.295.
13	Sec. 18.65.909. Definitions. In AS 18.65.900 - 18.65.909,
14	(1) "law enforcement agency" has the meaning given in AS 12.36.090;
15	(2) "unmanned aircraft system" means an unmanned aircraft that is
16	operated without direct human intervention from inside or on the aircraft and includes
17	the associated support equipment, control station, data links, telemetry,
18	communications, and navigation equipment necessary to operate the unmanned
19	aircraft;
20	(3) "unmanned aircraft system crew member" means a person other
21	than an unmanned aircraft system pilot who is assigned to duties related to an
22	unmanned aircraft system during flight;
23	(4) "unmanned aircraft system pilot" means a person exercising control
