Without it, any medevac to a Seattle hospital can be exorbitantly expensive. That happened to my next door neighbor, whose husband suddenly had to be medevaced to a Seattle hospital.

For our household, the AirCare membership will expire mid-May unless this legislation passes this session.

Again, thank you, and I shall be doing whatever my partially disabled condition allows me to do (such as messages to committees) to help move this legislation along expeditiously.

My name is Chris Guggenbickler and I am a self employed commercial fisherman who resides in Wrangell Alaska. I am also a volunteer fireman and EMT.

One of our duties as an EMT is to transport patients and Airlift Northwest crew to and from the hospital to the airport. Living in a small community such as Wrangell and other small communities in Alaska we do not have the facilities or personel available to deal with major life threatening medical situations. The best we can do is stabalize these patients and medivac them to a facility best suited to deal with their injuries. This happens all too often, from major trauma and cardiac emergencies to simpler procedure we just don't have the resources to deal with in a small community.

Our fire and EMS personel have been covered through this membership program. Prior to that my family was enrolled in the Airlift membership program.

As I can afford \$100 per year membership, a lifesaving flight could cripple my family financially.

I medevaced my 92 year old father to Virginia Mason in Seattle just this past New Year's Eve. The care received during the flight could not have been surpassed. I know as I was a flight nurse for SEARHC for 17 years.

This membership program is needed by the citizens of Alaska, as stated everywhere flying patients is expensive, not everything is covered by insurance. If you compare the population of South East Alaska with the population of Washington and realize that the 4,066 (of which two are my father and myself) enrolled in the program and the memberships of 23,901 in Washington, I'm sure that the ration of subscriptions to population will be much higher for us in Alaska.

Please don't let this bill be defeated. The only ones who will be hurt by not having the program will be us Alaskans.
