### William H. Henning

Professor Henning received a B A. from the University of Tennessee-Chattanooga in 1972, a J D. from the University of Tennessee College of Law in 1976, and an LL M. from the University of Illinois College of Law in 1982. He served for many years as the R.B. Price Professor of Law at the University of Missouri-Columbia School of Law before taking emeritus status in 2002 and moving Alabama. At Missouri, he was a three-time winner of the Distinguished Faculty Teaching Award and the first member of the law faculty to be selected for a William T. Kemper Fellowship for Teaching Excellence, awarded annually to ten faculty members from all areas of the university. He has published widely in the field of commercial law, including several books on aspects of the Uniform Commercial Code In 1994, Professor Henning was appointed to serve Missouri as a Commissioner with the Uniform Law Commission (ULC). In that capacity, he was a member, and then chair, of the Drafting Committee to Amend UCC Article 2 (Sales) and Article 2A (Leases) In 2001, while continuing his duties at Missouri, he became the ULC's Executive Director, a position he held until 2007. His responsibilities as Executive Director included selecting reporters for drafting projects, serving as liaison to the American Bar Association and the American Law Institute, and developing a framework for cooperation between the ULC and the U.S. State Department's Office of Private International Law. Although no longer Executive Director, he continues his work with the ULC as an Alabama Commissioner Professor Henning is a member of the Permanent Editorial Board for the Uniform Commercial Code, the American Law Institute, and the American Bar Association, and the State Department's Advisory Council on Private International Law He currently serves as a member of the U.S. Delegation to the United Nations Commission on International Trade Law, Working Group VI, which is preparing guidelines for a public registry system
