SUMMARY OF THE ENDANGERED SPECIES ACT PETITION PROCESS

I. THE LISTING PETITION PROCESS IN A NUTSHELL


- a. <u>Step 1</u>: The U.S. Fish and Wildlife Service ("FWS") or the National Marine Fisheries Service ("NMFS") receives a petition to list a species as threatened or endangered from an interested person.
- b. <u>Step 2</u>: FWS or NMFS determines, within 90-days, if the petition presents substantial information such that listing the species may be warranted.
 - i. If the petition does not present substantial information, no further action is taken.
 - ii. If the petition presents substantial information, FWS or NMFS proceeds to Step 3.
- c. <u>Step 3</u>: FWS or NMFS engages in a 12-month status review of the species. This leads to one of three results:
 - i. The listing is "not warranted," in which case no further action is taken.
 - ii. The listing is "warranted," in which case FWS or NMFS proceeds to Step 4.
 - iii. The listing is "warranted but precluded." This means action would be taken but the agency is precluded from doing so due to other pending proposals. The result is that the species is placed on a candidate species list. The status of the species is periodically reviewed until a decision is made to proceed to Step 4 or a "not warranted" finding is made.
- d. Step 4: FWS or NMFS determines listing the species is "warranted" and publishes a proposed rule with a comment period. FWS or NMFS must then publish a final rule within 12 months of the proposed rule to list. This results in one of two actions:
 - A final rule is published listing the species as threatened or endangered.
 - ii. The rule is withdrawn and the species is not listed.

II. THE DESIGNATION OF CRITICAL HABITAT PROCESS IN A NUTSHELL

- a. When a species is listed, the FWS and NMFS are also required to designate critical habitat. The agency may exclude some or all of the area in the designation if the benefits of doing so outweigh the benefits of the designation.
- b. <u>Step 1</u>: FWS or NMFS has 12 months from publication of the proposed rule listing a species to designate critical habitat. FWS or NMFS is to publish a final rule designating critical habitat concurrent with the final listing rule.
- c. <u>Step 2</u>: If critical habitat cannot be determined at the time of listing, then FWS or NMFS has an additional year to publish a final rule designating critical habitat.

This summary is intended to provide a very general overview of the ESA listing process for background purposes only. It is not intended to be a comprehensive analysis of the listing process.
