I am writing to say that I am very angry that the House Majority has introduced HB 384 in an attempt to circumvent the work and effort put forth by Alaskans to create a citizen's ballot initiative. We are not buying the excuse that this legislature is different than the one that overturned a similar bill in 2013. Ten Republican legislatures that gutted the bill in 2003 are still there today. Obstructionist techniques by Republicans nationally have galvanized people like I've never seen before and we will not stand for such obstructionism in our state. This is not the time to be pushing around common workers. We are organized and motivated. The votes are still being counted, but so far it looks like pro-union Pete Peterson has beat out Tea Party Trombley in east Anchorage. This was the first city election I have ever voted in. But not only did I vote, I took four other people to the polls with me who normally don't vote either. Those four people and myself have since been registering other normally non-voters. 
