Through local media coverage and by recounts from 'more-seasoned' Alaskan voters, I have been educated on the history of past wage initiatives like this one. In 2002, the legislature passed a minimum wage increase (which in my opinion was a way to *seemingly* satisfy voters), that was obviously only passed to be able to keep it off the ballot and out of the voters' power; then they turned around and passed a new minimum wage bill, gutting the previous year's increase, way after the fact.
